The Competent Authority has accepted your offered rates in connection with the subject work. The total cost of the work at the accepted rates works out to Rs. 516048602.44 (Rupees Fifty-One Crore Sixty Lakh Fourty-Eight Thousand Six Hundred And Two Rupees And Fourty-Four Paise Only)

A sum of Rs.12294400 deposited as Earnest Money vide IREPS reference ID ME310331242673 through Manual-Bank Guarantee no. 093BG01261590005, Dt: 08.06.2026 issued by YES Bank Limited has been retained towards initial Security Money for due and faithful fulfillment of the contract, and the balance Security Money will be recovered from the progressive bills @ 6 % of the bill amount till it reaches 5 % of the contract value in terms of clause 11 (1) of Chapter-3 of Annexed Document.. Or otherwise, if you so desire, the balance amount of Security Deposit of Rs. 13508030.12 (Rupees One Crore Thirty Five Lakh Eight Thousand Thirty and Paise Twelve Only) is to be deposited in cash with FA & CAO(Con)/E. Co.Railway/Bhubaneswar.

You are requested to submit Performance Guarantee in the form as given in Clause 11 (4) of Chapter-3 of Annexed Document. equivalent to 10 % of the contract value amounting to Rs. 51604860.24 (Rupees Five Crore Sixteen Lakh Four Thousand Eight Hundred And Sixty Rupees And Twenty-Four Paise Only) within 21 days from the date of issue of Letter of Acceptance, valid up to stipulated date of completion plus 60 days so that contract agreement can be executed. Extension of time for submission of PG beyond 21 (Twenty one) days and upto 60 days from the date of issue of LOA may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 12% per annum shall be charged for the delay beyond 21 (Twenty one) days, i.e. from 22nd day after the date of issue of LOA. Further, if the 60th day happens to be a declared holiday in the concerned office of the Railway, submission of PG can be accepted on the next working day. In all other cases, if the Contractor fails to submit the requisite PG even after 60days from the date of issue of LOA, the contract is liable to be terminated. In case contract is terminated, railway shall be entitled to forfeit Earnest Money Deposit and other dues payable against that contract. The failed contractor shall be debarred from participating in re-tender for that work.

The entire work shall be completed within 24 month from the date of issue of Letter of Acceptance. Please contact Dy. Chief Engineer/Con/RSP/BBS immediately with your execution programme to start the work on the authority of this Acceptance Letter.
