Order on Board

17.06.2026

1. Since the common facts are involved in the present cases, the same are clubbed together, heard together and decided by this common order.
2. These petitions have been filed by the petitioners being aggrieved by the notice dated 15.05.2026/14.05.2026, by which the petitioners-society are directed that the shortage of quantity displayed on the paddy procurement portal be promptly delivered, which are as follows:-

3. The above stated quantities of paddy were remaining at the Center till 13.05.2026 as displayed in the paddy procurement portal. By the said notice, it has been specifically mentioned that under the paddy procurement policy pertaining to the year 2025-26, no dry quantity/dryage in respect of paddy center would be allowed and as such, the petitioner was directed to give the quantity of paddy which has not been supplied.
4. Learned counsel for the petitioners would submit that they have already replied to the notice dated 15.05.2026/14.05.2026. However, the dispute has not been decided by the authorities

concerned till date, and as such, the authorities may be directed to consider the said replies of the petitioners and to pass an appropriate order on merits of the case and till then, the said authority may be directed not to take any coercive steps against the petitioners society.

5. On the other hand, learned advocates appearing for the respective respondents oppose the submissions made by learned counsel for the petitioners.
6. I have heard learned counsel for the parties and perused the documents placed on record with utmost circumspection.
7. Considering the limited prayer made in these petitions by the petitioners-society and further considering the fact that the replies have already been filed by the petitioners against the notice dated 15.05.2026/14.05.2026, this Court is of the opinion that the respondent authorities are under an obligation to decide the dispute strictly in accordance with the law. However, till the decision of the said dispute, the respondent authorities are directed not to take any coercive steps against the petitioners.
8. The authorities concerned would be at liberty to pass an appropriate orders on the merits of the case after affording due opportunity of hearing to the petitioners. The authorities concerned are directed to decide the said dispute within a period of 45 days from the date of receipt of copy of this order.

9. It is made clear that this Court has not made any observation on the merits of the case.
10. With the aforesaid observations and directions, these petitions are hereby **disposed of**.
