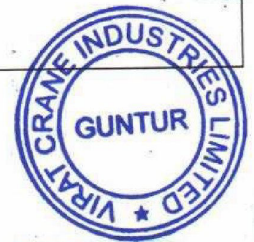

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015 (SEBI LODR) Company is in receipt of a notice for BSE dated 30.06.2026 regarding non-compliance with various provisions of SEBI (LODR) Regulations 2015 for the half year ended 31st March, 2026 and has imposed a fine of 5,900/- (inclusive of GST) for non-compliance of the provisions.

The Company has been proactively complying all regulatory compliances with in time so far and the above non -compliance was happened for only one day. The related party transaction report has to be submitted on the same day in which financial results are submitted. The related party transaction report was integral part of financial results XBRL report for the quarter/half year ended on 31-03-2026 which had to be submitted within 24 hours after board meeting where in the financial results were considered and approved for the quarter ended on 31-03-2026 for the F.y 2025-26 .The same was considered and approved in the board meeting held on 28-05-2026,due to the technical error occurred in presenting the XBRL report to BSE on the same day, the company could not present the XBRL on 28-05-2026 but submitted within 24 hours of the financial results to BSE. Hence technically the company complied above non -compliance with in time since it is integral part of financial report which can be submitted with in 24 of hours of board meeting in which financial results are declared but could not submitted on the same day of board meeting in which financial results are declared. The non-compliance with regard to the above regulations was neither due to negligence or default on the part of the company nor within the control of management of Virat Crane Industries Limited.
