1. The present Application has been filed by the Resolution Professional under Rule 11 read with Rules 164 and 165 of the National Company Law Tribunal Rules, 2016 seeking revival and restoration of IA(Plan) No. 19(AHM)2025 for adjudication in terms of the judgment dated 27.05.2026 passed by the Hon'ble National Company Law Appellate Tribunal in Company Appeal (AT) (Ins.) Nos. 512 of 2026 and 513 of 2026, with the following prayers:

- a. *allow the present Application;*
- b. *Direct Ld. Registry to restore and list IA(Plan)/19/(AHM)/2025 in CP(IB) No. 61/AHM/2025 before this Hon'ble Adjudicating Authority in compliance of directions passed by the Hon'ble NCLAT vide Order dated 27 .05.2026; and;*
- c. *pass any further order(s)/direction(s) as may deem fit to this Hon'ble Tribunal.*

2. It is submitted that IA(Plan) No. 19(AHM)2025 filed by the Resolution Professional for approval of the Resolution Plan submitted by Meghdoot Leisure LLP was rejected by this Adjudicating Authority vide order dated 12.03.2026. Aggrieved thereby, the Resolution Professional and the Successful Resolution Applicant preferred appeals before the Hon'ble National Company Law Appellate Tribunal.
3. The Hon'ble National Company Law Appellate Tribunal, vide judgment dated 27.05.2026, allowed the appeals, set aside the order dated 12.03.2026 and revived IA(Plan) No. 19(AHM)2025 for fresh consideration and passing of appropriate orders. The Hon'ble Appellate Tribunal further directed that the Adjudicating Authority shall proceed to pass an order with regard to approval of the Resolution Plan keeping in view the observations made therein and observed that the applications filed by Claro Energy shall stand closed.
4. Heard learned Counsel for the Applicant. Perused the material available on record.
5. In view of the judgment dated 27.05.2026 passed by the Hon'ble National Company Law Appellate Tribunal, IA(Plan) No. 19(AHM)2025 is required to be restored for fresh consideration.
6. Therefore, the Registry is directed to restore IA(Plan) No. 19(AHM)2025 in CP(IB) No. 61/AHM/2025 to its original number and place the same before the Bench on **24.06.2026** for consideration in accordance with law and in terms of the judgment dated 27.05.2026 passed by the Hon'ble National Company Law Appellate Tribunal.
7. Accordingly, **IA No. 861 of 2026** is allowed and disposed of. No order as to costs.
