A W A R D

1. Heard Amit P.Shahi, learned counsel appearing for Mr. Ashutosh Dubey, learned counsel for the petitioner and Mr. Rajeev Maheshwaranand Roy, learned counsel for the respondent No.3-Insurance Company instructed by Mr. Subaih, National Head Legal and Mr. Deepak Gupta, Deputy General Manager, Cholamandalam Insurance Company.

2. The parties have arrived at a settlement during the course of hearing. It is agreed that respondent No.3-Insurance Company shall pay a consolidated amount of Rs.40,00,000/- (Rupees forty lakhs) over and above the amount awarded by the High Court to the petitioner in full and final settlement of all their claims. The petitioner agrees that on receipt of the consolidated amount of Rs.40,00,000/- (Rupees forty lakhs) over and above the amount awarded by High Court, the petitioner will have no further claim whatsoever against the respondent No.3-Insurance Company.

3. The additional compensation of Rs.40,00,000/- (Rupees forty lakhs) shall be paid to the petitioner. The petitioner shall furnish the account details to the respondent-Insurance Company. On due verification, the amount of Rs.40,00,000/- (Rupees forty lakhs) shall be directly transferred to the petitioner within a period of 30 days.

4. The Special Leave Petition is disposed of in the above terms.

5. We place on record our appreciation for the learned counsel for the parties, Mr. Subaih, National Head Legal and Mr. Deepak Gupta, Deputy General Manager, Cholamandalam Insurance Company for the positive and spontaneous response they have shown in settling the matter.
