A W A R D

1. The parties on both the sides appeared virtually and state that the compensation payable in the subject-matters has been finalized at Rs.5,08,000/- (Rupees five lakhs eight thousand

only) per acre with statutory benefits.

2. To the said effect, the parties have arrived at a settlement and the terms of settlement are placed before this Lok Adalat.

3. The present special leave petitions are disposed of in terms of the settlement arrived at between the parties, which shall form part of the Award.

4. Consequently, the claimants are entitled to the compensation of Rs.5,08,000/- (Rupees five lakhs eight thousand only) per acre with statutory benefits and the parties have agreed to waive the interest for the delayed period in filing the present petitions.

5. Court fee be refunded as per rules.
