With reference to the Postal Ballot Notice of the Company dated May 12, 2026, which was duly circulated to all the shareholders of the Company, we hereby clarify that an inadvertent error had occurred in the Explanatory Statement of said Notice, specifically under Item No. 1(e) and Item No. 2(e), as mentioned below:

The proposed allotment is less than 5% of the post-issue fully diluted share capital of the Company. Accordingly, the reference to the proposed allotment being "more than 5%" in the Postal Ballot Notice was inadvertent and may kindly be read as "less than 5%".

Further, the Company had duly issued and disseminated a Corrigendum dated June 4, 2026, inter alia, clarifying that the Valuation Report was obtained voluntarily and was made available to the shareholders.

This intimation is being issued in continuation of the Postal Ballot Notice dated May 12, 2026, and the Corrigendum dated June 4, 2026.
