**UPON hearing the counsel the Court made the following
O R D E R**

Mr. Tushar Mehta, learned Solicitor General, and other senior counsels appearing for parties supporting the Union of India, have sought adjournment on two grounds.

Firstly, it is submitted that a curative petition is pending in respect of a judgment delivered by a Nine-Judge Bench of this Court, upon which reliance has been placed by the petitioners i.e. the State Authorities. It is urged that the present matter be listed after the said curative petition is decided.

Secondly, it is submitted that the Constitution Bench hearing is still going on, in which the learned Solicitor General and most of the senior counsels are engaged. On this ground as well, a request has been made that the matter be taken up in the month of July, 2026.

However, in view of the objection raised by the State Authorities, who claim benefit of the Nine-Judge Bench Judgment, we direct that the matter to be listed on 20.05.2026.
