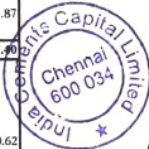





Note:

- 1) The above financial results reviewed by the Audit Committee were approved by the Board of Directors at its meeting held on 29th May, 2026.
- 2) The Company is Primarily engaged in buying & selling of Foreign Currencies and its wholly owned Subsidiary is engaged in Brokerage Business in Share and dealing in Mutual Funds, Bonds etc.,
- 3) Revenue from Operations of the Standalone company includes income from air ticketing and Forex Advisory Services. Since the turnover for other activities is less than 10 percent of the total turnover they are not reportable Segments under Accounting Standard "Segment reporting".
- 4) The Statutory Auditors have carried out audit of the Financial results for the Quarters and Year Ended 31st March, 2026.
- 5) The figures for the corresponding period of the previous year, have been reclassified/regrouped wherever necessary to comply with current period required classification.
- 6) During the reporting period, the Company was subjected to an incident of cyber crime/ fraud, resulting in fraudulent transfer of Rs.80.00 Lakhs from the company's bank account to unauthorized/unknown recipients. A formal complaint has been lodged with the Cyber Crime Cell, Chennai and appropriate legal recourse is being pursued for recovery of the amount. Out of the said fraudulent transfer, a sum of Rs.31.85, lakhs has since been recovered and considering the complexities involved in recovering the amount, it was felt prudent to writeoff balance Rs 48.15 lakhs. Cyber Crime Department have filed the Case in Magistrate court against the Accused and the Trial will start from June 2026.-The Statutory Auditor have drawn an emphasis of Matter in their report.
- 7) On November 21, 2025 the Government of India notified four Labour Codes, effective immediately, replacing the existing 29 labour laws. In accordance with guidance issued by the Institute, of Chartered Accountants India and based on actuarial valuation, the Company has assessed and disclosed the financial impact under Exceptional items in the financial results for the Year ended 31/03/2026. The Company has recognized Rs 23.79 Lakhs as statutory impact of New Labour Codes towards Employee benefits obligations, classified as past service cost, primarily due to the revised definition of wages under the labour Codes. The Company continues to monitor the developments relating to the implementation of the Labour Codes and will review the estimates as further clarification and Rules are notified..
- 8) Long Term Borrowings amounting to Rs 43.55 crores which are no longer payable have been written back.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 9) The amount of Rs 43.38 crores written off represents funds provided to an entity and considering its financial condition, it is felt prudent to writeoff the amount.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 10) A sum of Rs. 0.22 crore, deployed towards forex broking services is considered not recoverable and hence written off.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 11) Based on opinion obtained from tax consultant no provision for tax has been made on account of write back of Rs 43.55 crores and writeoff Rs 43.60 crores.- The Statutory Auditor have drawn an emphasis of Matter in their report.

Report on the audit of the Standalone Financial Results

Opinion

We have audited the accompanying standalone quarterly financial results of India Cements Capital Ltd. (the company) for the quarter ended 31st March 2026 and the year to date results for the period from 1st April 2025 to 31st March 2026 attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:

- i. Are presented in accordance with the requirements of Regulation 33 of the Listing Regulations in this regard; and
- ii. Give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable Indian accounting standards and other accounting principles generally accepted in India of the net loss and other comprehensive income and other financial information for the quarter ended 31st March 2026 as well the year to date for the period from 1st April 2025 to 31st March 2026.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013 (the Act). Our responsibilities under those Standards are further described in the *Auditor's Responsibilities for the Audit of the Standalone Financial Results* section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants



of India together with the ethical requirements that are relevant to our audit of the financial results under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter

Out of the said fraudulent transfer, a sum of Rs.31.85, lakhs has since been recovered and considering the complexities involved in recovering it was felt prudent to write off balance of Rs 48.15 lakhs. Cyber Crime Department have file the case in Magistrate court against the accused and trial will start from June 2026.
2. Note No.8 of the STATEMENT OF STANDALONE AUDITED FINANCIAL RESULTS FOR THE QUARTER AND YEAR ENDED 31ST MARCH, 2026 which states "Long Term Borrowings amounting to Rs 43.55 Crores which are no longer payable have been written back."
3. Note No.9 of the STATEMENT OF STANDALONE AUDITED FINANCIAL RESULTS FOR THE QUARTER AND YEAR ENDED 31ST MARCH, 2026 which states" The amount of Rs 43.38 crores written off represents funds provided to an entity and considering its financial condition, it is felt prudent to write off the amount.
4. Note No.10 of the STATEMENT OF STANDALONE AUDITED FINANCIAL RESULTS FOR THE QUARTER AND YEAR ENDED 31ST MARCH, 2026 which states" A sum of Rs 0.22 crore, deployed towards Forex broking services is considered not recoverable and hence written off.
5. Note No.11 of the STATEMENT OF STANDALONE AUDITED FINANCIAL RESULTS FOR THE QUARTER AND YEAR ENDED 31ST MARCH, 2026 which states" Based on opinion obtained from tax consultant no provision for tax has been made on account of write back of Rs.43.55 Crores and write off Rs.43.60 Crores."

Our opinion is not modified in respect of this matter.



Key Audit Matters

The Company's Board of Directors are responsible for the preparation of these financial results that give a true and fair view of the net loss and other financial information in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, 'Interim Financial Reporting' prescribed under Section 133 of the Act read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial results that give a true and fair view and are free from material misstatement, whether due to fraud or error.

A formal complaint has been lodged with the Cyber Crime Cell, Chennai and appropriate legal recourse is being pursued for recovery of the amount. Out of the said fraudulent transfer, a sum of Rs.31.85, lakhs has since been recovered and considering the complexities involved in recovering the amount, it was felt prudent to writeoff balance Rs 48.15 lakhs. Cyber Crime Department have filed the Case in Magistrate court against the Accused and the Trial will start from June 2026.-The Statutory Auditor have drawn an emphasis of Matter in their report.
- 7) On November 21, 2025 the Government of India notified four Labour Codes, effective immediately, replacing the existing 29 labour laws. In accordance with guidance issued by the Institute, of Chartered Accountants India and based on actuarial valuation, the Company has assessed and disclosed the financial impact under Exceptional items in the financial results for the Year ended 31/03/2026. The Company has recognized Rs 23.79 Lakhs as statutory impact of New Labour Codes towards Employee benefits obligations, classified as past service cost , primarily due to the revised definition of wages under the labour Codes. . The Company continues to monitor the developments relating to the implementation of the Labour Codes and will review the estimates as further clarification and Rules are notified.
- 8) Long Term Borrowings amounting to Rs 43.55 crores which are no longer payable have been written back.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 9) The amount of Rs 43.38 crores written off represents funds provided to an entity and considering its financial condition, it is felt prudent to writeoff the amount.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 10) A sum of Rs. 0.22 crore, deployed towards forex broking services is considered not recoverable and hence written off.- The Statutory Auditor have drawn an emphasis of Matter in their report.
- 11) Based on opinion obtained from tax consultant no provision for tax has been made on account of write back of Rs 43.55 crores and writeoff Rs 43.60 crores- The Statutory Auditor have drawn an emphasis of Matter in their report.
