Dear Sir/Madam,

This is with reference to the Observation of BSE regarding disclosure of detailed reasons for delay/non-submission of the Financial Results in accordance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In this regard, we respectfully submit that the Company had already intimated the Exchange on 29th May, 2026 regarding the postponement of the Board Meeting scheduled for consideration and approval of the Audited Financial Results for the quarter and financial year ended 31st March, 2026. The Intimation dated 29th May, 2026 along with its Acknowledgement is attached to this Letter and marked as Annexure A. The said intimation specifically stated that the postponement was due to unavoidable circumstances relating to the finalisation of accounts and other connected matters.

Further, we wish to submit that the delay occurred as the Company was required to prepare and publish Consolidated Financial Results and, at the relevant time, was in the process of consolidating the financial statements and financial information of its associate entities. The Company was undertaking a process of finalisation of accounts, including reconciliation of financial records, verification of balances, review of accounting treatments, completion of audit-related procedures and resolution of various matters connected with the consolidation process to ensure accuracy, completeness and compliance with applicable accounting standards and regulatory requirements.

Considering the significance of these processes and in the interest of presenting true and correct financial results to the Board and stakeholders, additional time was required for finalisation of the accounts, which resulted in the postponement of the Board Meeting and consequent delay in submission of the Financial Results.
