Signing of SJVA-III between NTPC Limited (NTPC) and Uttar Pradesh Rajya Vidyut Utpadan Nigam Limited (UPRVUNL).

NTPC Limited (NTPC) & Uttar Pradesh Rajya Vidyut Utpadan Nigam Limited (UPRVUNL) has signed Supplementary Joint Venture Agreement (SJVA)-III for Meja Urja Nigam Private Limited (MUNPL), a 50:50 JV Company of NTPC & UPRVUNL on 4th June 2026 at Lucknow for incorporation of provisions related to capacity enhancement of Meja Stage-II from 2x660 MW to 3x800 MW in the Joint Venture Agreement (JVA).
