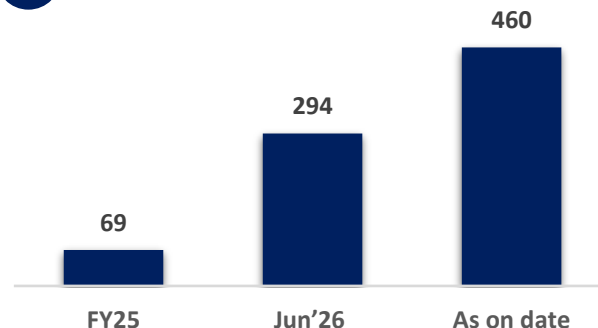

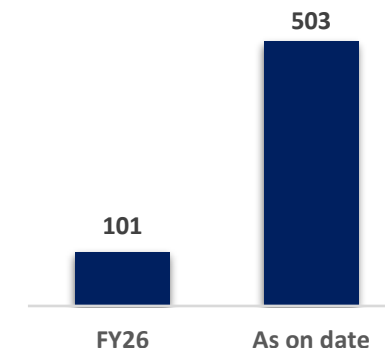
Total Operational Portfolio Capacity (MWp)



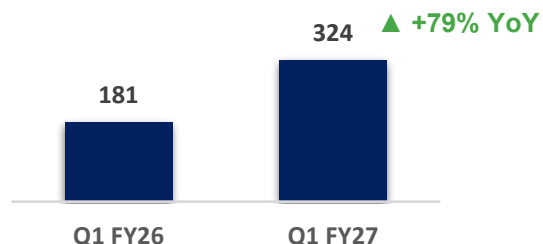
Total Operational Wind Capacity (MW)



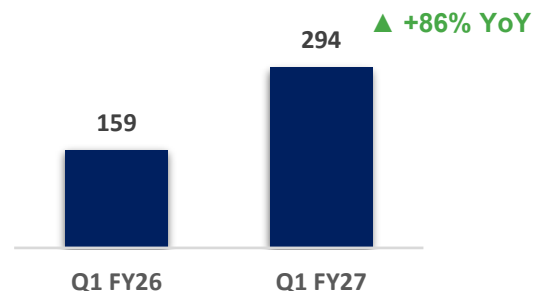
Total Operational BESS Capacity (MWh)



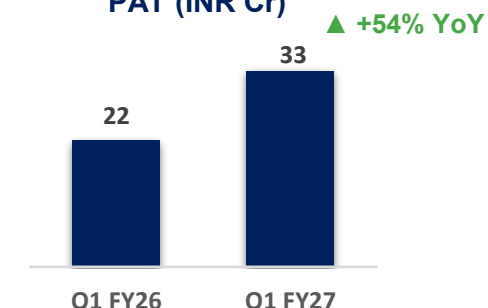

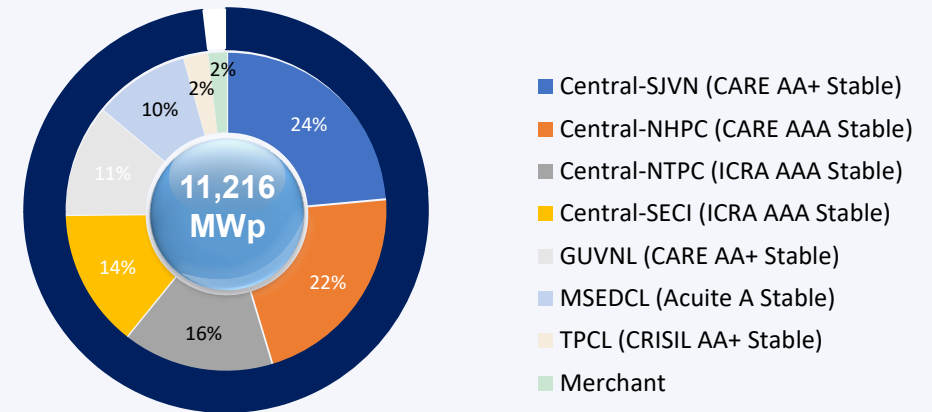

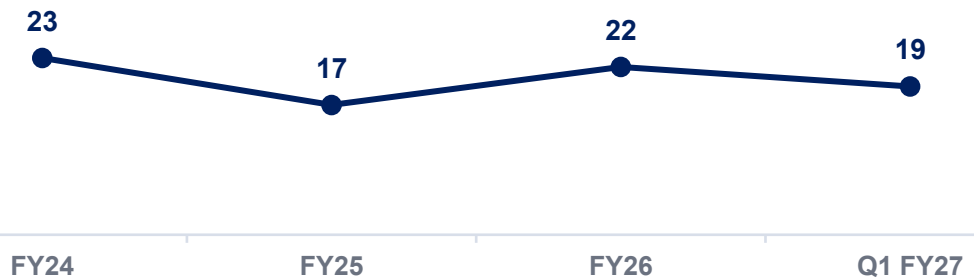

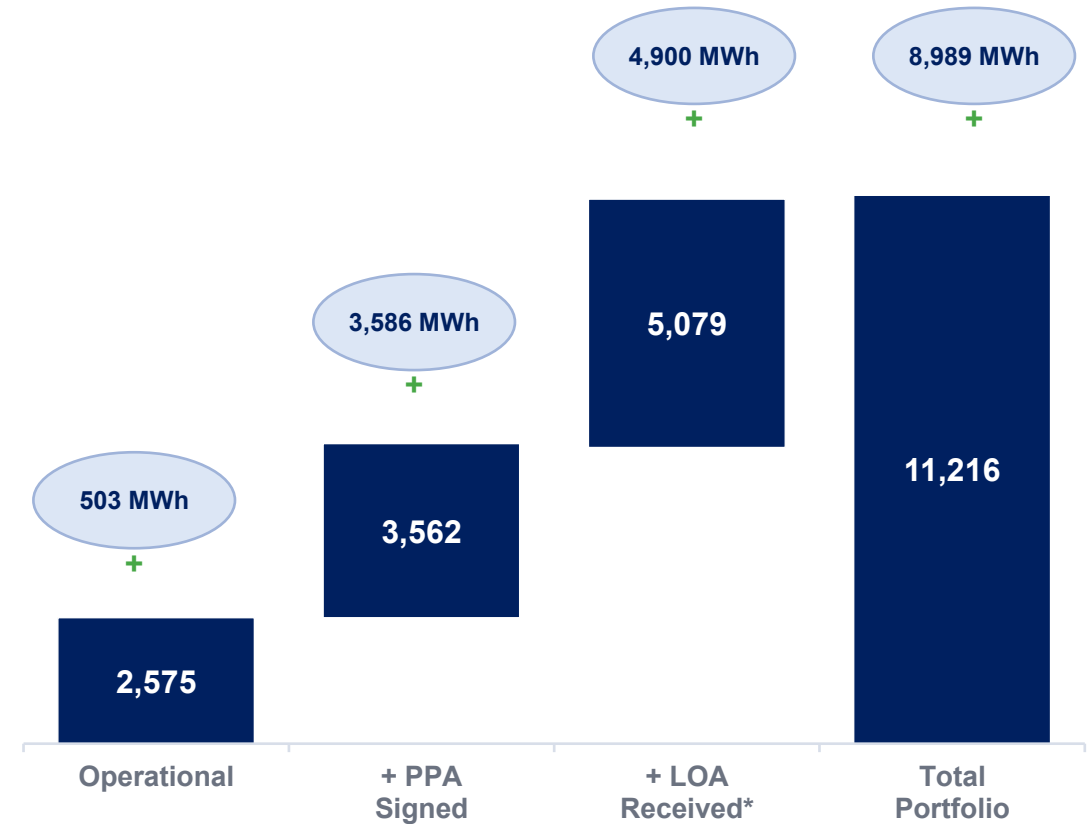
