A W A R D

1. Heard Ms. Akhila Wali, learned counsel appearing for the petitioners and Mr. Rajeev Maheshwaranand Roy, learned counsel for the respondent No.2-Insurance Company, instructed by Mr. Sahil Gupta.

2. The parties have arrived at a settlement during the course of hearing. It is agreed that respondent No.2-Insurance Company shall pay a consolidated amount of Rs.19,00,000/- (Rupees nineteen lakhs) over and above the amount awarded by the High Court to the petitioners in full and final settlement of all their claims. The petitioners agree that on receipt of the consolidated amount of Rs.19,00,000/- (Rupees nineteen lakhs) over and above the amount awarded by High Court, the petitioners will have no further claim whatsoever against the respondent No.2-Insurance Company.

3. The additional compensation of Rs.19,00,000/- (Rupees nineteen lakhs) shall be paid to the petitioners. The petitioners shall furnish the account details to the respondent-Insurance Company. On due verification, the amount of Rs.19,00,000/- (Rupees nineteen lakhs) shall be directly transferred to the petitioners within a period of 30 days.

4. The Special Leave Petition is disposed of in the above terms.

5. We place on record our appreciation for the learned counsel for the parties and Mr. Sahil Gupta for the positive and spontaneous response they have shown in settling the matter.
