2. Respondent no.11, Dr. Chandresh Jain, is present in-person. He seeks and is granted two weeks' time to file the counter affidavit.

3. Issue notice, returnable on 28.10.2026.

Rest of the matters

4. Learned Solicitor General of India, on instructions, states that the consequential benefits attached to the Transgender Identity Card, which were issued earlier, shall continue to operate as valid, subject to outcome of the instant proceedings.
5. Counter affidavit, if any, be filed within three weeks. It would be appreciated if a consolidated counter-statement is filed by the Union of India, responding to all the claims in the various petitions forming part of this batch.
6. Post these matters on 28.10.2026.
7. On the suggestion of learned Senior Counsel/Counsel for the petitioners, Mr. Rajagopalan R @ Kanmani R., learned counsel, assisted by Mr. Yashwant Singh, AOR, is appointed as nodal counsel on behalf of the petitioners and intervenor-applicants, who are laying challenge to the Impugned Amendment. Similarly, Mr. Annam Venkatesh, learned counsel, is appointed as nodal counsel on behalf of the respondents, opposing the challenge.
