ORDER

1. In the present petition bearing (IB) - 314(PB)/2023, the arguments were heard, and the order was reserved on 08.05.2026. Vide the same order following clarifications were sought:

- i. The Corporate Person has trade creditors to the tune of INR 34,10,942/- (Rupees Thirty Four Lakhs Ten Thousand Nine Hundred Forty Two only). Whether these creditors filed their claim or not. Whether any distribution has been made to them. Please, provide chart containing particulars of these creditors, nature of transaction with them (Contract), amount outstanding and duration, whether claim filed or not, and whether distribution made or not.
- ii. RoC had undertaken to file NoC during the course of the hearing held on 30.04.2025, however the same has not been filed. RoC is therefore directed again to file NoC.

- iii. The Application is directed to file a record reflecting the closure of Bank Accounts.
2. Pursuant to the above, an affidavit dated 18.05.2026 has been filed wherein clarification has been furnished only qua the 1st point without any documentary proof. Further, as regards the 2nd point, the Applicant has annexed only the letters requesting the banks for the closure of the accounts, and there is no proof of closure yet.
3. Further, RoC has not filed NoC as directed.
4. Therefore, we issue directions to the Applicant as well as NoC to take requisite steps as per directions passed in the order dated 08.05.2026 and file an appropriate affidavit providing complete and comprehensive details in compliance of order dated 08.05.2026 within two week.
5. Subject to above, **order reserved**.
