Furtherance to our intimation dated 25th December 2025, we wish to inform you that KNR Constructions Limited (the “Company”) has transferred 99.90% i.e 480,262 equity share capital in one of its subsidiary company ie KNR Ramagiri Infra Private Limited (“SPV/KRIPL”) to Indus Infra Trust (“Purchaser”) and balance 0.10% i.e 488 equity shares held by the Company could not be transferred to Purchaser due to technical issue but economic benefit/interest on such equity shares have been lying with the Purchaser only.

The Company had invested Rs. 82.75 crore (in the form of Equity and Subordinated Debt) in the SPV. Pursuant to the transaction, the Company has received a consideration of Rs. 227.45 Crore from the Purchaser.
