O R D E R

1. We heard Mr. Neeraj Kishan Kaul, the learned Senior counsel appearing for the appellant, Mr. Rishav Banerjee, the learned counsel appearing for the auction purchaser i.e. Respondent No.10, the learned counsel appearing for the liquidator and Mr. Siddarth Sangal, the learned counsel appearing for the Respondent No.1.

2. We are of the view that no error not to speak of any error of law could be said to have been committed by the National Company Law Appellate Tribunal, Principal Bench, New Delhi in dismissing the appeal preferred by the appellant before us.

3. We take notice of the fact that the asset in question was put to auction 1 ½ years back. The Respondent No.10 is the successful auction purchaser. It paid the amount of Rs.63.6 Crore to the liquidator.

4. Since we are dismissing the appeal, the title deeds and other documents of the asset in question which are in possession of the appellant shall now be handed over to the Respondent No.10 at the earliest.

5. The Liquidator shall now proceed to execute the conveyance deed in favour of the Respondent No.10 - Auction purchaser.
6. With the aforesaid, the appeal stands dismissed.
7. Pending applications, if any, also stand disposed of.
