Dear Shareholder/Investor,

Sub: Reminder for claiming the unclaimed dividend(s) to avoid transfer of unclaimed dividend(s) and equity share(s) of the Company against which dividend(s) has not been claimed for seven consecutive years or more to the Investor Education and Protection Fund.

We draw your kind attention to the dividend warrant(s)/demand draft(s) issued to you for the dividend(s) declared by Star Paper Mills Limited ("the Company") pertaining to Financial Years 2018-19 to 2024-25 for shares held by you in the Company.

We find from our records that the said dividend warrant(s)/demand draft(s) have not been encashed by you. - Accordingly, you are requested to send Investor Service Request Form ISR-1, Form ISR-2 and Form No. SH-13 (Nomination Form) / ISR-3 (Declaration to Opt-out from providing Nomination) duly filled as per the instructions stated therein along with the supporting documents for updation of PAN/ KYC/ Bank Details/ Nomination details, etc. Format of the same and other details are available on the website of the RTA and the company.

You are also requested to update your bank details (NECS details) with the Depository Participants/Company's Registrar and Share Transfer Agent for online and timely remittance of dividend; and also register your email-id for prompt communication from the Company in future.

Further, we request you to convert your physical shares into Demat mode as per SEBI guidelines for mandatorily dematerialization of physical shares held by an Investor.
