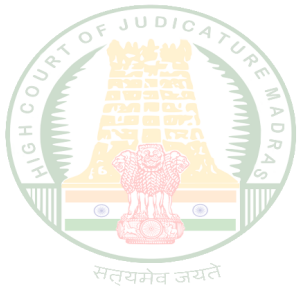

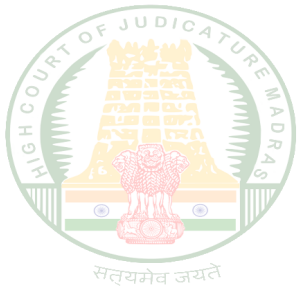

ORDER

The petitioner, an employee of the Tamil Nadu State Transport Corporation (Madurai) Ltd, Madurai/the respondent herein has filed this writ petition, with a grievance that his representation, dated 20.07.2026, to withdraw a sum of Rs.5,24,000/- from his Provident Fund Account has not been considered by the respondent.

2.The learned counsel appearing for the petitioner submits that the petitioner has arranged his daughter's marriage on 13.09.2026 and he has also submitted a representation for partial withdrawal of his Provident Fund amount, however the same has not been considered by the respondent.

3.Mr.K.Ramaiah, learned Standing Counsel takes notice for the respondent and seeks some accommodation to get instructions.

4.Considering the relief sought for in this writ petition that the petitioner has requested to withdraw the Provident Fund amount accumulated in his PF account for his daughter's marriage scheduled on 13.09.2026, this writ petition is allowed with a direction to the respondent Corporation to pay the eligible Provident Fund amount to this petitioner within a period of one week from the date of receipt of a copy of this order. No costs.

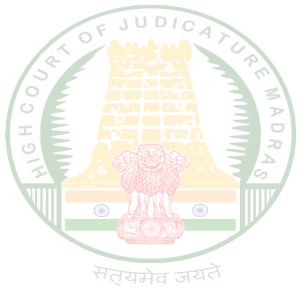
