O R D E R

1. The appellant has filed the present appeal challenging the judgment/order dated 06.02.2024 passed by the High Court of Delhi in CrI. M.C. No.5269 of 2023.

2. We have heard the learned counsel for the parties and perused the material available on record.

3. Learned counsel appearing for the parties submit that the parties have amicably resolved their disputes. The private respondents have undertaken to pay a sum of Rs.2,00,000/- (Rupees two lakh only) to the appellant within a period of three (03) months from today in the following manner:

i) The first installment of Rs.1,00,000/- (Rupees one lakh only) shall be paid on or before 11.06.2026;

ii) The second installment of Rs.50,000/- (Rupees fifty thousand only) shall be paid on or before 04.08.2026; and

iii) The third installment of Rs.50,000/- (Rupees fifty thousand only) shall be paid on or before 04.09.2026.

The said undertaking is accepted and taken on record.

4. The amount shall be deposited directly into the bank account of the appellant. Learned counsel for the appellant shall furnish the bank particulars of the appellant to learned counsel for the private respondents forthwith.

5. The private respondents, through their learned counsel present in the Court, have been made aware of the consequences of a breach of such terms, including the initiation of contempt proceedings.

6. Accordingly, the present appeal is disposed of.

7. Pending application(s), if any, shall stand disposed of.
