UPON hearing the counsel the Court made the following
O R D E R

Pursuant to order dated 20.04.2026, the petitioner(s) have paid 70,00,000/- (Rupees Seventy Lakhs Only) to the respondent(s) which is admitted by the learned counsel for the respondent(s).

Mr. S.K. Gangele, learned senior counsel, submits that the balance 70,00,000/- (Rupees Seventy

Lakhs Only), as per the aforesaid order would also be paid within the next two months.

On the other hand, learned counsel appearing for respondent(s) submits that the amount of Rs.1,40,00,000/-, indicated in the order dated 20.04.2026, was mentioned without proper mathematical calculation. However, after due calculation, it has been found that the actual amount due after receiving 70,00,000/- is Rs.1,07,11,000/- approximately.

We will consider the said objection raised by the learned counsel for the respondent(s) after the balance amount of Rs.70,00,000/- as per the order dated 20.04.2026 is paid within the next two months.

List the matter again on 21.09.2026.
