UPON hearing the counsel the Court made the following
O R D E R

1. While issuing notice in the lead matter on 19.09.2025, this Court directed that the petitioner shall not be terminated from service and at the same time made it clear that this Court had not

stayed the operation of the impugned order passed by the High Court.

2. The paragraph 39 of the impugned order directs that SECL (South Eastern Coalfields Limited) and District Rehabilitation Resettlement Committee (DRRC) of the State Government shall examine the claims of remaining eligible person under R&R Policy, 1991 and CIL R&R Policy, 2012 and all the remaining eligible persons under these two policies be given employment. This exercise be completed within one month from the date of order of the High Court.

3. Ms. Archana Pathak Dave, Ld. ASG and Mr. Tiwari, learned Senior Counsel appearing for SECL would submit that the exercise as contained in para 39 of the impugned order is not yet complete. Mr. Nikhil Goel, learned Senior Counsel appearing for some of the private respondents would submit that the exercise had infact been earlier completed.

4. In view of the above, let Mr. Arkaj Kumar learned Counsel appearing for the State of MP seek positive instructions on the above aspect.

5. List the matter on 01.10.2026.

6. Let service be completed in terms of order dated 01.09.2026.

7. Interim order(s) to continue till the next date of hearing.
