Roles & Responsibilities: To exercise substantial powers of management of the affairs and business of the Company, including overall supervision and management of its day-to-day operations, implementation of the business plans and policies approved by the Board, execution of contracts and documents, representation of the Company before various authorities and stakeholders, management of financial, operational and administrative functions, and to perform such other duties and exercise such powers as may be entrusted by the Board from time to time, subject always to the superintendence, control and direction of the Board of Directors.

NOTES

1. **A MEMBER ENTITLED TO ATTEND AND VOTE AT THE MEETING IS ENTITLED TO APPOINT A PROXY TO ATTEND AND POLL TO VOTE INSTEAD OF HIMSELF / HERSELF AND SUCH PROXY NEED NOT BE A MEMBER. THE INSTRUMENT APPOINTING A PROXY SHOULD HOWEVER BE DEPOSITED AT THE REGISTERED OFFICE OF THE COMPANY NOT LESS THAN 48 HOURS BEFORE THE COMMENCEMENT OF THE MEETING.**
2. A person can act as proxy on behalf of Members not exceeding fifty (50) and holding in aggregate not more than 10% of the total share capital of the Company. In case a proxy is proposed to be appointed by a member holding more than 10% of the total share capital of the Company carrying voting rights, then such proxy shall not act as a proxy for any other person or shareholder.
3. In case of joint holders attending the Meeting, only such joint holder who is higher in the order of names will be entitled to vote.
4. Pursuant to Section 113 of the Companies Act, 2013, corporate members intending to appoint authorized representatives to attend the meeting are requested to send a certified copy of the Board Resolution authorizing their representative to attend and vote on their behalf at the meeting.
5. Pursuant to Section 91 of the Companies Act, 2013 the register of members and share transfer books of the Company will remain closed from **Thursday, 17th September 2026 to Wednesday, 23rd September 2026** (both days inclusive) for the purpose of Annual General Meeting.
6. As per Regulation 40 of SEBI Listing Regulation, as amended, securities of listed companies can be transferred only in dematerialized form with effect from 1st April 2019, except in case of request received for transmission or transposition of Securities. In view of this and to eliminate all risk associated with physical form shares and for ease of portfolio management, members holding shares in physical form are requested to consider converting their holdings to dematerialized form. Members can contact the Company or Company's Registrars and Transfer Agents, XL Softech Systems Limited, 3, Sagar Society, Road No.2, Banjara Hills, Hyderabad – 500034, Telangana, India for assistance in this regard.
7. 11. The Company's Equity shares are listed at BSE Limited., Phiroze Jeejeebhoy Towers, Dalal Street, Mumbai – 400001, Maharashtra, India and the Company has paid the Listing Fees to the said Stock Exchange.
12. As per Securities and Exchange Board of India (SEBI), it is now mandatory to furnish a Copy of PAN Card to the Company or its RTA in the following cases viz. Transfer of Shares, Deletion of Name, Transmission of Shares and Transposition of Shares. Shareholders are requested to furnish a copy of the PAN card for all the above-mentioned transactions.
13. The Scrutinizer shall, after the conclusion of voting at the AGM, first count the votes cast during the Meeting and, thereafter, unblock the votes cast through remote e-Voting, in the presence of at least two witnesses not in the employment of the Company and shall make, not later than two (2) working days from the conclusion of the AGM, a Consolidated Scrutinizer's Report of the total votes cast in favour or against, if any, to the Chairman or a person authorized by him in writing, who shall countersign the same and declare the result of the voting forthwith.

The Scrutinizer, after scrutinizing the vote cast at the meeting and through remote e-voting, will not later than two (2) working days of conclusion of the meeting, make a consolidated scrutinizer's report and submit the same to the Chairman. The results shall simultaneously be communicated to BSE Limited.

VOTING THROUGH ELECTRONIC MEANS:

- Pursuant to provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time and in pursuance with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company is pleased to provide its members' the facility of 'remote e-voting (e-voting from a place other than venue of AGM) to exercise their right to vote at the 32nd Annual General Meeting ("AGM") by electronic means and the business may be transacted through e-voting services provided by CDSL on all resolutions set forth in this Notice. The members may cast their votes using an electronic voting system from a place other than the venue of the meeting ('remote e-voting').
- In order to enable its members, who do not have access to e-voting facility, to send their assent or dissent in writing in respect of the resolutions as set out in the Notice of Annual General Meeting; the Company has also enclosed a ballot form with the Annual Report for the financial year 2025-26.
- The facility for voting through polling paper shall be made available at the meeting and the members attending the meeting who have not cast their vote by remote e-voting/ ballot form shall be able to vote at the Meeting through polling paper.
- A member can opt for only single mode of voting i.e., either through e-voting or by Ballot Form. If a member casts the vote by both modes, e-voting shall prevail and vote by Ballot shall be treated as invalid. The members who have cast their vote by remote e-voting/ballot form may also attend the meeting but shall not be entitled to cast their vote again.
- The Voting rights of the members shall be in proportion to the paid-up value of their shares in the Equity Capital of the Company as on cut-off date **Wednesday, 16th September 2026**.
- A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the **cut-off date, i.e. Wednesday, 16th September 2026** only shall be entitled to avail the facility of remote e-voting, voting through ballot form and voting at AGM through polling paper.

During this period, shareholders of the Company holding shares either in physical or in dematerialized form, as on the cut-off date, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.

The instructions for shareholders to vote electronically are as under:

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

STEP-1: ACCESS THROUGH DEPOSITORIES CDSL/NSDL E-VOTING SYSTEM IN CASE OF INDIVIDUAL SHAREHOLDERS HOLDING SHARES IN DEMAT MODE:

In terms of **SEBI circular no. 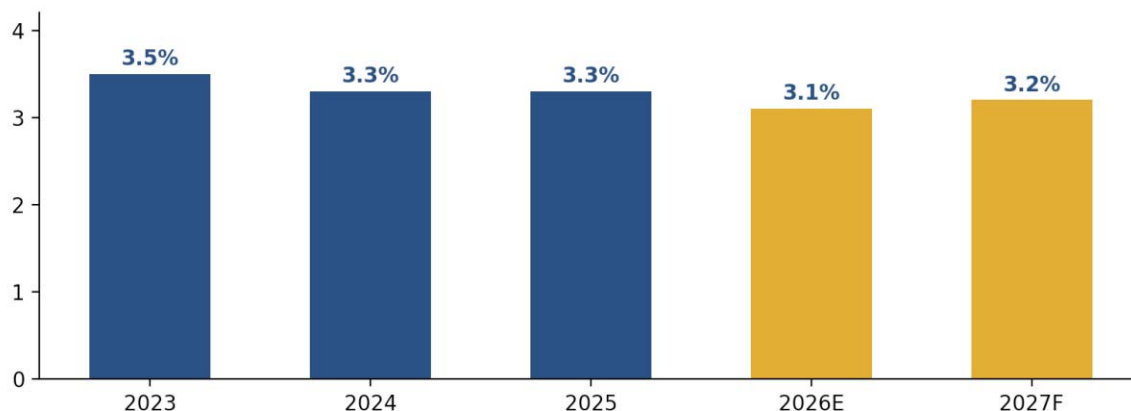

MANAGEMENT DISCUSSION ANALYSIS REPORT

[Pursuant to Regulation 34 read with Para B of Schedule V of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015]

The Directors of your Company are pleased to present the Management Discussion and Analysis Report for the financial year ended 31st March 2026.

The Indian textile and apparel industry remains one of the oldest and largest sectors of the Indian economy, contributing about 11% of India's manufacturing Gross Value Added (GVA) and around 11% of the country's total merchandise exports. India continues to be the sixth largest exporter of textiles and apparel globally, holding a share of nearly 4% of the global trade in this segment. Within this broader canvas, the handmade carpet and floor coverings segment continues to be a significant value-added, employment-intensive export category for the country.

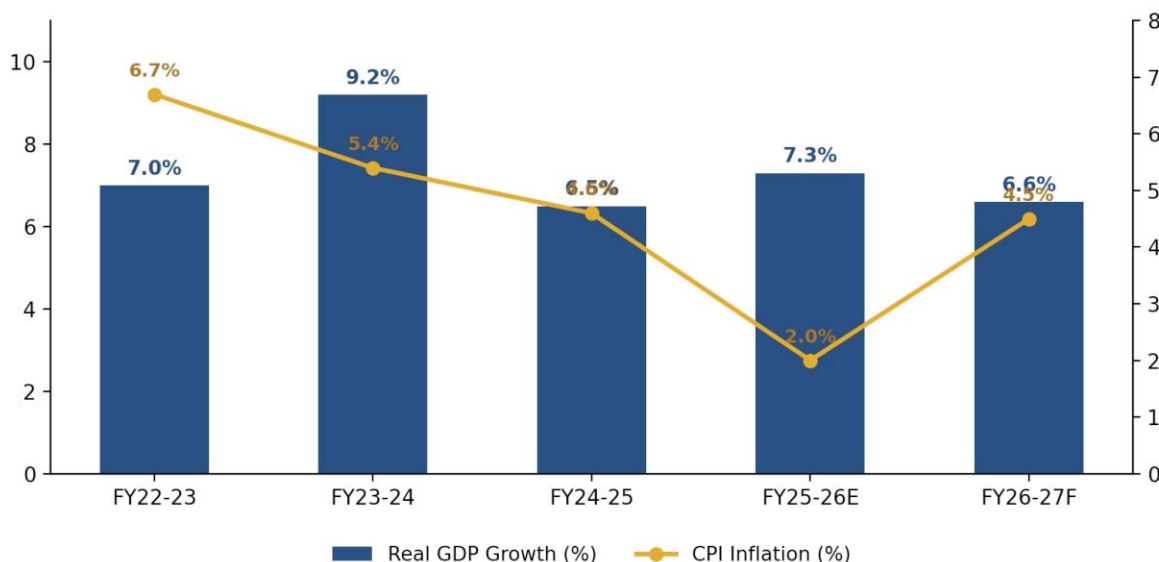
GLOBAL ECONOMY OVERVIEW:

Calendar year 2025 saw the global economy display steady, if unspectacular, resilience of around 3.3% growth, aided by robust technology-sector investment, favourable financial conditions and continued fiscal and monetary support, even as elevated trade barriers and policy uncertainty persisted through the year. This momentum, however, has been abruptly interrupted in 2026 by the outbreak of conflict in the Middle East, which has triggered a fresh round of commodity price volatility, firmer inflation expectations and tighter financial conditions across major economies.

Assuming the conflict remains limited in duration and scope, global growth is projected to moderate to 3.1% in 2026 and recover marginally to 3.2% in 2027, a step down from the 2024-25 trend and well below the pre-pandemic historical average of 3.7%. Global headline inflation is expected to tick up in 2026, before resuming its downward trajectory in 2027. The slowdown in growth and rise in inflation are expected to be more pronounced in emerging market and developing economies, particularly commodity importers with pre-existing external vulnerabilities.

Downside risks continue to dominate the outlook. A longer or broader conflict, deepening geopolitical fragmentation, a reassessment of expectations around artificial-intelligence-driven productivity gains, or a renewed escalation in trade tensions could weaken growth and unsettle financial markets further. Elevated public debt levels and eroding institutional and policy buffers in several economies add to these vulnerabilities, underscoring the need for a balanced policy approach focused on structural reforms and strengthened multilateral cooperation.

**INDIAN ECONOMY OVERVIEW:**

India continues to be one of the fastest growing major economies in the world, and this resilience was clearly on display through the financial year under review. Real GDP growth accelerated through FY 2025-26, rising from 7.8% in the first quarter to a six-quarter high of 8.2% in the second quarter, driven by robust domestic consumption, buoyant services and industrial activity, and a supportive fiscal and monetary environment. On the back of this momentum, the Reserve Bank of India (RBI) progressively revised its full-year GDP growth projection for FY 2025-26 upward, from an initial estimate of 6.5% to 7.3%.

The inflation environment through the year was unusually benign, described by the RBI Governor as a 'rare Goldilocks period' of high growth alongside exceptionally low inflation. Headline retail (CPI) inflation eased through the year to reach multi-year lows, aided by a sharp correction in food prices, a favourable monsoon, softer global crude prices, and the beneficial pass-through of the GST rate rationalisation implemented from September 22, 2025. This provided the RBI with the policy space to reduce the repo rate to 5.25% during the year while maintaining a neutral stance.

On the external front, India's current account deficit remained well contained, supported by strong services exports, robust remittance inflows and steady FDI inflows. A significant positive development during the year was the reduction in US reciprocal tariffs on Indian goods from a peak of 50% to 18%, easing pressure on export-oriented sectors including textiles and carpets. India also concluded the India-UK Comprehensive Economic and Trade Agreement (CETA), which is set to come into force from July 15, 2026 and will eliminate tariffs on nearly 99% of Indian exports to the UK, including textiles, home furnishings and carpets.

Looking ahead, international agencies remain broadly consistent in projecting continued robust growth for India through FY 2026-27, in the range of 6.2% to 6.6%, positioning India to remain among the fastest-growing major economies notwithstanding the headwinds emanating from the Middle East conflict and global trade uncertainty.

INDIA'S LEADERSHIP IN HAND-MADE CARPETS:

India remains the world's foremost producer and exporter of handmade carpets, leading in both volume and value. India's carpet exports grew from approximately US \$1.39 billion in FY 2023-24 to about US \$1.54 billion in FY 2024-25, representing nearly 40% of global handmade carpet exports. Indian carpets reach over 70 countries, with key importers including the United States, Germany, the United Kingdom, Australia, Canada, South Africa, France, Italy, and Brazil. India's historic tradition of craftsmanship, centred in major clusters such as Bhadohi/Mirzapur (Uttar Pradesh), Rajasthan, Jammu & Kashmir, Telangana, Gujarat, and others, supports over 2 million artisans, mostly rural and women, working across a wide range of carpet types (Indo-Persian, silk, wool, Kilim, hand-tufted, etc.).

The sector stands to benefit meaningfully from two favourable trade developments during the year: the reduction in US tariffs on Indian goods from 50% to 18%, and the India-UK CETA coming into force from July 15, 2026, which eliminates UK import duties of up to 12% on textiles and floor coverings, placing Indian exporters on a level footing with competing sourcing hubs such as Bangladesh, Vietnam and Cambodia. Industry strategies continue to evolve towards digital customisation, e-commerce platforms and sustainable, traceable product lines, supported by Government initiatives spanning skill development, trade events, financial incentives and Geographical Indication (GI) protections for clusters such as Bhadohi and Kashmir.



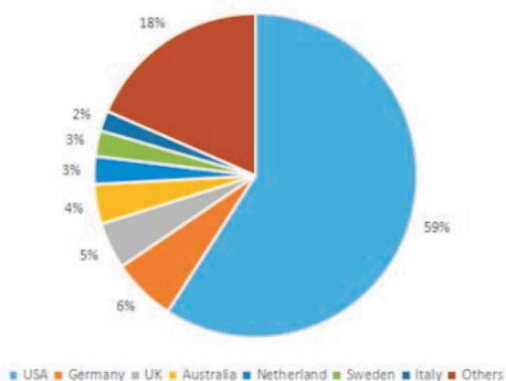
INDUSTRY STRUCTURE AND DEVELOPMENT:

India's carpet manufacturing segment continues to benefit from the country's broader ambition to scale its textile sector to US \$350 billion by 2030, with exports expected to contribute US \$100 billion. The Union Budget 2025-26 raised textile sector outlays by nearly 19% to support modern PM MITRA textile parks, R&D centres and skill missions, while the Production Linked Incentive (PLI) scheme continues to channel investment into export-ready value addition across the sector.

The industry is further supported by an expanding network of trade agreements. Alongside the India-UK CETA and the reduced US tariff regime, India concluded a Free Trade Agreement with New Zealand in April 2026 and announced the conclusion of India-EU FTA negotiations in January 2026, both of which are expected to widen market access for labour-intensive sectors including carpets and home textiles over the medium term.

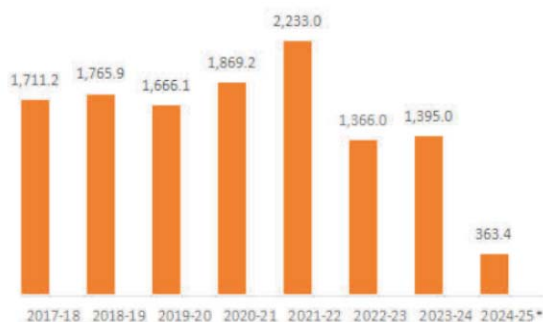
However, the carpet industry continues to face structural challenges, including continued reliance on outdated weaving technology, high fixed-cost structures, infrastructure gaps, and mounting competition from machine-made imports, particularly from Turkey, which continues to impose high import duties on Indian-origin carpets while India's own duty structure remains comparatively favourable to machine-made imports. These constraints collectively exert pressure on operating margins. As the Company continues to invest in automation, design innovation, strategic partnerships, and digital marketing, its performance trajectory remains tied to both domestic reforms and global trade dynamics.

OPPORTUNITIES AND THREATS:

Opportunities:

1. Favourable Government Initiatives

- Expansion of PM MITRA Parks, the PLI scheme, and the nearly 19% increase in textile sector outlay under the Union Budget 2025-26, aimed at improving infrastructure, reducing logistics costs, and supporting capacity expansion for textile and carpet manufacturers.



2. India-UK CETA and Improved US Tariff Regime

- The India-UK Comprehensive Economic and Trade Agreement, effective July 15, 2026, eliminates UK duties of up to 12% on textiles and carpets, while the reduction in US tariffs on Indian goods from 50% to 18% materially improves cost competitiveness in the Company's two largest export markets.

3. Export Growth Potential

- India targets US \$100 billion in textile exports by 2030 (from a base of approximately US \$35-39 billion), with strong demand for high-value handmade carpets and floor coverings continuing to underpin this ambition.

4. Rising Global Preference for Sustainable Products

- Increasing demand for eco-friendly, natural fibre, and handcrafted carpets aligns with India's traditional strengths in artisanal craftsmanship and traceable, low-carbon production.

5. Digitisation & Direct-to-Consumer Channels

- Increasing adoption of e-commerce platforms, digital design tools, and online customisation enables direct access to global customers and niche interior segments.

6. Product Diversification

- Opportunities to expand into carpet tiles, luxury vinyl flooring, and custom floor coverings catering to hospitality, office, and commercial spaces.

Threats:

1. Technological and Cost Disadvantages

- Continued reliance on manual production and outdated machinery leads to lower productivity and higher fixed costs compared to global competitors using automated systems.

2. Unfavourable Trade Dynamics

- Export competitiveness continues to be hampered by unequal tariff structures, such as high import duties on Indian carpets in Turkey (~46%) versus comparatively lower duties on machine-made imports into India (~20%).

3. Geopolitical and Global Demand Risks

- The outbreak of conflict in the Middle East in 2026 has introduced fresh volatility in energy prices, freight costs and global financial conditions, with a longer or wider conflict, or renewed trade tensions, posing risks to demand in key export markets (US, UK, EU).

4. Operational and Regulatory Challenges

- Complex labour laws, infrastructure gaps, and fluctuating raw material prices increase operational uncertainty and reduce cost efficiency.



5. Raw Material and Supply Chain Issues

- Rising raw material prices, scarcity of wool fibres, and supply delays and discontinuities constrain the ability of Indian manufacturers to compete with other carpet-producing countries, impacting export volumes from India.

SEGMENT WISE PERFORMANCE:

The Company operates in a single segment, i.e. the carpets business. Hence, the Business Segments reporting in accordance with the applicable Accounting Standard on 'Operating Segments' is not applicable.

DISCUSSION ON FINANCIAL PERFORMANCE WITH RESPECT TO OPERATIONAL PERFORMANCE:

The financial statements of the Company for FY 2025-26 have been prepared in accordance with the applicable provisions of the Companies Act, 2013 and the Indian Accounting Standards (Ind AS) notified thereunder, and form part of this Annual Report. The Company's operational performance during the year under review, including turnover, profitability and key operating metrics, has been discussed in detail in the Board's Report and the financial statements, to which reference is invited.

OUTLOOK:

The outlook for the Indian carpet and flooring industry remains constructive, underpinned by sustained global demand, an improving trade-policy environment following the India-UK CETA and the reduced US tariff regime, and emerging opportunities in digital and sustainable manufacturing. India continues to be the world's largest exporter of handmade carpets, commanding nearly 40% of global market share, and remains well positioned to benefit from the Government's broader vision to expand textile exports to US \$100 billion by 2030, with carpets and floor coverings identified as a key value-added export segment.

The India carpets and rugs market is estimated at approximately US \$1.18 billion in 2026, and is projected to grow at a CAGR of over 9% through 2031, driven by rising demand for eco-friendly, artisanal, and customisable products in high-income markets such as the United States, Europe, the UK, and newer geographies including Scandinavia and Latin America. The growing importance of sustainability and traceability in global sourcing continues to create favourable conditions for Indian handmade carpets, which are perceived as ethical, durable, and environmentally responsible.

Domestically, increasing urbanisation, rising disposable incomes, and evolving interior decor preferences continue to spur demand for high-quality carpets, rugs, and flooring materials in residential and commercial segments. At the same time, Government initiatives such as PM MITRA Parks, the enhanced PLI outlay under the Union Budget 2025-26, and targeted investment in export clusters like Bhadohi and Mirzapur are expected to enhance production capacity, reduce costs, and improve logistical efficiencies across the value chain.

However, the industry must continue to navigate structural challenges, including technological gaps, high fixed costs, and trade-related asymmetries, even as it contends with near-term global uncertainty arising from the Middle East conflict and its impact on energy prices and freight costs. While competing countries such as Turkey and China continue to gain ground in machine-made carpets through automated production and aggressive pricing, India's long-term competitiveness will depend on modernisation, skill development, and the adoption of digital technologies such as AI-enabled design, virtual customisation, and direct-to-consumer (D2C) marketing. Overall, the Company remains cautiously optimistic about the medium- to long-term prospects of the Indian carpet industry, and aims to capture emerging growth opportunities while mitigating structural and market-driven risks.



RISK AND CONCERNS:

In line with regulatory requirements, the Company has framed a Risk Management Policy to identify and assess key business risk areas and a risk mitigation process. A detailed exercise is carried out at regular intervals to identify, evaluate, manage and monitor all business risks. The Board periodically reviews these risks and suggests steps to control and mitigate the same through a properly defined framework.

In today's complex and rapidly evolving business environment, almost every business decision requires the management to balance risk and reward. Effective risk management is therefore critical to the Company's continued success. Increasing integration of global markets, evolving products and transactions, and an increasingly stringent regulatory framework require an integrated approach to risk management. The sustainability of the Company's business is derived from the following:

- Identification of the diverse risks faced by the Company, including geopolitical, trade-policy, currency, raw material and technology-related risks.
- The evolution of appropriate systems and processes to measure and monitor such risks.
- Risk management through appropriate mitigation strategies within the policy framework.
- Continuous analysis and review of all such risks at various levels of management through an effective information system.

INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY:

The Company has implemented a comprehensive and well-structured internal control system that is commensurate with the nature, scale, and complexity of its business operations. The system is designed to ensure efficiency in operations, compliance with applicable laws and regulations, and safeguarding of assets. It encompasses all critical business processes, including procurement, production, sales, finance, and human resources. The Company continuously monitors the effectiveness of these controls through regular management reviews, and the Statutory Auditors have, in their report, commented on the adequacy and operating effectiveness of the Company's internal financial controls over financial reporting for the year under review.

MATERIAL DEVELOPMENT IN HUMAN RESOURCES:

The Company continues to maintain good and cooperative relationships with its employees. This positive environment helps improve employee performance and encourages them to work effectively with the Company. As on March 31, 2026, the Company had 8 permanent employees on its rolls.

The Company also ensures a safe and respectful working environment, with strict measures in place to prevent any kind of physical, verbal, or sexual harassment and is in compliance with the provisions of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

SIGNIFICANT CHANGES IN THE KEY FINANCIAL RATIOS AND OTHER PARAMETERS:

There have been no material changes in the key financial ratios or other financial parameters of the Company during the financial year under review, as compared to the previous year. The Company continues to maintain financial stability and operational consistency across all core performance indicators.



DISCLOSURE OF ACCOUNTING TREATMENT:

In the preparation of the financial statements for FY 2025-26, the Company has followed the treatment prescribed under the applicable Indian Accounting Standards (Ind AS), and no treatment different from that prescribed in any Accounting Standard has been followed.

Notes to Financial Statements for the year ended March 31, 2026**Note: 1****1.1 Company Overview**

Golden Carpets Ltd (the "Company") is a public limited Company incorporated on 2nd December 1993 and its shares are publicly traded on the BSE Limited (BSE), in India. The registered office of the Company is situated at 8-2-596/5/B/1, Road No.10, Banjara Hills, Hyderabad-500035, Telangana, India.

The Company is principally engaged in the manufacturing of carpets.

These financial statements are presented in Indian Rupee with figures rounded off to nearest rupee except otherwise as indicated.

1.2 Basis of Preparation of Accounts

These financial statements are prepared in accordance with the Indian Accounting Standards (Ind AS) under the historical cost convention on the accrual basis, except for certain financial instruments which are measured at fair values and the provisions of the Companies Act, 2013 ('the Act') The Ind AS are prescribed under Section 133 of the Act read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and amendments thereto.

Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy thereto in use. The Company retains the presentation and classification of items in the financial statements from one period to the next.

- 1.3 The Company has determined its operating cycle as 12 months for the purpose of classification of current and non-current assets and liabilities. This is based on the nature of product and the time between the acquisition of inventories for processing and their realization in cash and cash equivalents. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III (Division II) to the Companies Act, 2013.

Deferred tax assets and deferred tax liabilities are classified as non-current assets and non-current liabilities.

1.4 Use of Estimates and Judgements

The preparation of the standalone financial statements in conformity with Ind AS requires the Management to make estimates, judgements and assumptions. These estimates, judgements and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgements and the use of assumptions in financial statements have been specified in Note 1.5 below. Accounting estimates could change from period to period. Actual results could differ from estimates. Appropriate changes in estimates are made as the Management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in financial statements in the period in which the changes are made and, if material, their effects are disclosed in these notes to the individual financial statements.



1.5 Critical Accounting Estimates and Judgement used in application of Accounting Policies:

a. Income Taxes

Significant judgements are involved in determining the provision for Income Taxes, including amount expected to be paid / recovered for uncertain tax positions. Also refer Note 5 (Deferred Tax).

b. Property, Plant and Equipment

Property, Plant and Equipment represent a significant proportion of the asset base of the Company. The charge in respect of periodic depreciation is derived after determining an estimate of an asset's expected useful life and the expected residual value at the end of its life. The useful life and residual values of the Company's assets are determined by the Management at the time the asset is acquired and reviewed periodically, including at each financial year end. The life is based on historical experience with similar assets as well as anticipation of future events, which may impact their life, such as changes in technology. (Refer Note 3)

Note 2

2.1 Significant Accounting Policies

2.1.1 Revenue Recognition

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are exclusive of taxes and net of returns, Trade Allowances, Rebates, other similar allowances, Goods and Service Tax and amounts collected on behalf of third parties, if any.

The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the Company and specific criteria have been met for each of the Company's activities as described below:

2.1.1.a Sale of Goods

Revenue from the sale of goods is recognised when the goods are delivered, and titles have passed, at which moment all the following conditions are satisfied:

- The Company has transferred to the buyer significant risks and rewards of ownership of the goods;
- The Company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- The amount of revenue can be measured reliably;
- It is probable that economic benefits associated with the transaction will flow to the Company; and
- The costs incurred or to be incurred in respect of the transaction can be measured reliably.



2.1.1.b Dividend Income

Dividend income from investments is recognised when the Company's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably).

2.1.1.c Interest Income

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis by reference to the principal amount outstanding and at the effective interest rate. Effective interest rate is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

2.1.2 Inventories

Inventories are measured at cost and net realizable value, whichever is lower. Net realizable value is the estimated selling price in the ordinary course of business less estimated cost necessary to make sale. Cost in respect of raw materials and stock in trade are determined on FIFO basis. Costs in respect of all other Inventories are computed on weighted average basis method. Finished goods and process stock include cost of conversion and other costs incurred in acquiring the inventory and bringing them to their present location and condition.

Inventories are written down to net realizable value item by item except where it is appropriate to group similar or related items. When a decline in the price of materials, indicates that the cost of the finished products exceeds net realizable value, the materials are written down to their replacement cost. When the circumstances that previously caused inventories to be written down below cost no longer exist or when there is clear evidence of an increase in net realizable value because of changed economic circumstances, the amount of the write-down is reversed so that the new carrying amount is the lower of the cost and the revised net realizable value. Inventories are recognised as expense in the period in which the related revenue is recognised.

2.1.3 Property, Plant and Equipment

2.1.3.a Recognition of Property, Plant and Equipment

Property, plant and equipment are tangible items that are held for use in the production or supply of goods and services, rental to others or for administrative purposes and are expected to be used during more than one period. The cost of an item of property, plant and equipment is recognised as an asset if and only if it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. Freehold land is carried at cost less accumulated impairment losses. All other items of property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. Cost of an item of property, plant and equipment comprises:

- Its purchase price, all costs including financial costs till commencement of commercial production are capitalized to the cost of qualifying assets. CENVAT/Tax credit, if any, are accounted for by reducing the cost of capital goods;
- Any other costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.



All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

2.1.3. b Depreciation of Property, Plant and Equipment

Each part of an item of property, plant and equipment with a cost that is significant in relation to the total cost of the item is depreciated separately on straight-line method. Parts of plant and equipment that are technically advised to be replaced at prescribed intervals / periods of operation, insurance spares and cost of inspection / overhauling are depreciated separately based on their specific useful life provided these are of significant amounts. The depreciation charge for each period is recognised in profit or loss unless it is included in the carrying amount of another asset. Depreciable amount of an item of property, plant and equipment is arrived at after deducting estimated residual value. The depreciable amount of an asset is allocated on a systematic basis over its useful life as disclosed in Note 3A. The Company reviews the residual value and useful life at each financial year-end and, if expectations differ from previous estimates, the residual value and useful lives are changed prospectively and accounted for as a change in accounting estimate. Depreciation commences when the item of property, plant and equipment is in the location and condition necessary for it to be capable of operating in the manner intended by management. Depreciation ceases at the earlier of the date that the asset is classified as held for sale (or included in a disposal group that is classified as held for sale) and the date that the asset is derecognized. The Company review the depreciation method at each financial year- end and if, there has been a significant change in the expected pattern of consumption of the future economic benefits embodied in the asset, the method is changed to reflect the changed pattern. Such a change is accounted as a change in accounting estimate on prospective basis.

2.1.3.c Compensation for Impairment

The Company recognises compensation from third parties for items of property, plant and equipment that were impaired, lost or given up in profit or loss when the compensation becomes receivable.

2.1.3. d Derecognition of Property, Plant and Equipment

The carrying amount of an item of property, plant and equipment is derecognized on disposal or when no future economic benefits are expected from its use or disposal. The gain or loss from the derecognition of an item of property, plant and equipment is recognised in profit or loss when the item is derecognized.

2.1.4 Leases

The Company determines an arrangement as a lease based on the substance of the arrangement after assessing whether the arrangement is dependent on the use of specific asset or assets and whether the arrangement conveys a right to use the asset or assets. The Company classifies all leases into finance and operating leases at the earlier of the date of the lease agreement and the date of commitment by the parties to the principal provisions of the lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership. A lease is classified as an operating lease if it does not transfer substantially all the risks and rewards incidental to ownership. The Company has applied accounting for leases for assets taken on lease. The Company has not given assets on lease.

**2.1.4. a Finance lease as lessee**

The Company recognises property leased under finance leases at the lower of the fair value of the lease property and present value of minimum lease payments. Lease payments are discounted at the interest rate implicit in the lease to calculate present value of minimum lease payments. Initial direct costs are added to the amount recognised as an asset. Minimum lease payments are apportioned between the finance charge and the reduction of the outstanding liability. Contingent rents are charged as expenses in the period in which they are incurred. The leased property is depreciated as per the depreciation policy specified in Note 2.1.3.

2.1.4. b Operating lease as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed or the payments to the lessor are structured to increase in line with expected general inflation to compensate for the lessor's expected inflationary cost increases. Where payments to the lessor are structured to increase in line with expected general inflation to compensate for the lessor's expected inflationary cost increases, lease expense is recognised based on the contractual lease payments. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

2.1.5 Employee Benefits**2.1.5. a Short-term Employee Benefits**

Short-term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the reporting period in which the employees render the related service. Short-term employee benefits include salaries, wages, social security contributions, bonus, paid annual leave etc. Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in.

2.1.7 Foreign currency transactions and translations

Functional currency of the Company is Indian rupee. The financial statements have been presented under its functional currency. Any transaction that is denominated in a currency other than the functional currency is regarded as foreign currency transaction. All foreign currency transactions are recorded, on initial recognition in the functional currency, by apply to the foreign currency amount the spot exchange rate between the functional currency and the foreign currency at the date of the transaction. In case of consideration received in advance, the exchange rate prevailing on the date of receipt or payment of advance is considered when subsequently the related asset is given up or received to the extent of advance consideration.

At the end of the reporting period:

1. Foreign Currency Monetary items are translated using the exchange rate for immediate delivery at the end of the reporting period;
2. Non-Monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rate at the date of the transaction; and
3. Non-Monetary items that are measured at fair value in a foreign currency are translated using



the exchange rates at the date when the fair value was measured. Exchange difference arising on the settlement of monetary items or on translating monetary items at rates different from those at which they were translated on initial recognition during the period or in previous financial statements are recognised in profit or loss in the period in which they arise.

2.1.8 Borrowing Costs

Interest and other costs that the Company incurs in connection with the borrowing of funds are identified as borrowing costs. The Company capitalises borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset as part of the cost of that asset. Other borrowing costs are recognised as an expense in the period in which it is incurred. A qualifying asset is an asset that necessarily takes a substantial period of time to get ready for its intended use. The Company identifies the borrowings into specific borrowings and general borrowings. Specific borrowings are borrowings that are specifically taken for the purpose of obtaining a qualifying asset. General borrowings include all other borrowings and also the amount outstanding as on the balance sheet date of specific borrowings. Borrowing cost incurred actually on specific borrowings are capitalised to the cost of the qualifying asset. For general borrowings, the company determines the amount of borrowing costs eligible for capitalisation by applying a capitalisation rate to the expenditures on the qualifying asset based on the weighted average of the borrowing costs applicable to general borrowings. The capitalisation on borrowing costs commences when the company incurs expenditure for the asset, incurs borrowing cost and undertakes activities that are necessary to prepare the asset for its intended use or sale. The capitalisation of borrowing costs is suspended during extended periods in which active development of a qualifying asset is suspended. The capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

2.1.9. a Recognition, classification, measurements and derecognition of Financial Assets

Financial assets include cash and cash equivalents, trade and other receivables, investments in securities and other eligible current and non-current assets. At initial recognition, all financial assets are measured at fair value. Such financial assets are subsequently classified and measured under one of the following three categories according to the purpose for which they are held and contractual Cash Flow characteristics. Financial assets are reclassified only when the purpose for which they are held changes. Financial assets are derecognised when the right to cash flows from the financial asset expires or when the financial asset is transferred resulting in transfer of significant risks and rewards to the buyer. Where significant risks and rewards are retained on transfer of a financial asset, the financial asset is not derecognised, and a financial liability is recognised for the consideration received. Where the transfer of financial asset results in partial transfer of risks and rewards, the asset is derecognised if the buyer obtains the right to sell the asset to other party unilaterally without attaching any conditions otherwise the financial asset continues to be recognised to the extent of continuing involvement.

2.1.9.a.i Financial Assets at amortised cost

Financial assets at amortised cost, at the date of initial recognition, are held to collect contractual cash flows of principal and interest on principal amount outstanding on specified dates. These financial assets are intended to be held until maturity. Therefore, they are subsequently measured at amortised cost by applying the Effective Interest Rate (EIR) method to the gross carrying amount of the financial asset. The EIR amortisation is included as interest income in the profit or loss. The losses arising from impairment are recognised in the profit or loss.

**2.1.9.a.ii Financial asset at Fair Value through Other Comprehensive Income (FVOCI)**

Financial asset at FVOCI, at the date of initial recognition, are held to collect contractual cash flows of principal and interest on principal amount outstanding on specified dates, as well as held for selling. Therefore, they are subsequently measured at each reporting date at fair value, with all fair value movements recognised in Other Comprehensive Income (OCI). Interest income calculated using the Effective Interest Rate (EIR) method, impairment gain or loss and foreign exchange gain or loss are recognised in the Statement of Profit and Loss. On derecognition of the asset, cumulative gain or loss previously recognised in Other Comprehensive Income is reclassified from the OCI to Statement of Profit and Loss.

2.1.9.a.iii Financial assets at Fair Value through Profit or Loss (FVPL)

Financial Assets at FVPL, at the date of initial recognition, are held for trading, or which are measured neither at Amortised Cost nor at Fair Value through OCI. Therefore, they are subsequently measured at each reporting date at fair value, with all fair value movements recognised in the Statement of Profit and Loss.

2.1.9. b Impairment of Financial Assets

The Company recognizes the impairment on financial assets based on the expected credit loss model for the financial assets which are not measured at fair value through profit or loss. In case of trade receivables, the Company follows a simplified approach wherein an amount equal to lifetime ECL is measured and recognized as loss allowance. In case of other financial assets expected credit losses are measured at an amount equal to 12-month ECL unless there has been significant increase in credit risk from initial recognition in which case these are measured at lifetime expected credit loss. The amount of expected credit losses or reversal that is required to adjust the loss allowance at the reporting date to the amount that is required to be recognized is recognized as an impairment gain or loss in the profit and loss for the period.

2.1.9.c Recognition, classification, measurement and derecognition of financial liabilities

Financial liabilities include long-term and short- term loans and borrowings, trade and other payables and other eligible current and non- current liabilities. All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and other payables, net of directly attributable transaction costs. The Company derecognises a financial liability when the obligation specified in the contract is discharged, cancelled or expires.

After initial recognition, financial liabilities are classified under one of the following two categories:

2.1.9.c.i Financial liabilities at amortised cost

After initial recognition, such financial liabilities are subsequently measured at amortised cost by applying the Effective Interest Rate (EIR) method to the gross carrying amount of the financial liability. The EIR amortisation is included in finance expense in the statement profit or loss.

2.1.9.c.ii Financial liabilities at Fair Value through Profit or Loss (FVPL)

Financial Liabilities at FVPL are those which are designated as such on initial recognition, or which are held for trading. Fair value gains / losses attributable to changes in own credit risk is recognised in OCI. These gains /losses are not subsequently transferred to Statement of Profit



and Loss. All other changes in fair value of such liabilities are recognised in the Statement of Profit and Loss.

2.1.10 Off-setting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise assets and settle liabilities simultaneously.

2.1.11 Earnings per Share

Basic earnings per share is calculated by dividing the profit or loss for the period attributable to the equity holders of the company by the weighted average number of ordinary shares outstanding during the year. For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares. (Refer Note 23)

2.1.12 Impairment of Non-Financial Assets

The Company reviews the carrying amounts of its Property, Plant and Equipment, including Capital Work in progress of a "Cash Generating Unit" (CGU) at the end of each reporting period to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the assets is estimated in order to determine the extent of the impairment loss (if any). When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the Cash Generating Unit to which the asset belongs.

Recoverable amount is determined:

- i) In case of individual asset, at higher of the fair value less cost to sell and value in use; and
- ii) In case of cash generating unit (a Company of assets that generates identified, independent cash flows), at the higher of the cash generating unit's fair value less cost to sell and the value in use.

If the recoverable amount of an asset (or cash generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognized immediately in the Statement of Profit and Loss.

2.1.13 Provisions, Contingent Liabilities and Contingent Assets

The Company recognizes provisions when a present obligation (legal or constructive) as a result of a past event exists and it is probable that an outflow of resources embodying economic benefits will be required to settle such obligation and the amount of such obligation can be reliably estimated. If the effect of time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not require an outflow of resources embodying economic benefits or the amount of such obligation cannot be measured reliably. When there is a possible obligation or a present obligation in respect of which likelihood of



outflow of resources embodying economic benefits is remote, no provision or disclosure is made. Contingent assets are not recognised but disclosed where an inflow of economic benefits is probable.

24.1.14 Intangible Assets

The Company identifies an identifiable non-monetary asset without physical substance as an intangible asset. The Company recognises an intangible asset if it is probable that expected future economic benefits attributable to the asset will flow to the entity and the cost of the asset can be measured reliably. An intangible asset is initially measured at cost unless acquired in a business combination in which case an intangible asset is measured at its fair value on the date of acquisition. The Company identifies research phase and development phase of an internally generated intangible asset. Expenditure incurred on research phase is recognised as an expense in the profit or loss for the period in which incurred. Expenditure on development phase are capitalised only when the Company is able to demonstrate the technical feasibility of completing the intangible asset, the ability to use the intangible asset and the development expenditure can be measured reliably. The Company subsequently measures all intangible assets at cost less accumulated amortisation less accumulated impairment. An intangible asset is amortised on a straight-line basis over its useful life. Amortisation commences when the asset is in the location and condition necessary for it to be capable of operating in the manner intended by management. Amortisation ceases at the earlier of the date that the asset is classified as held for sale (or included in a disposal group that is classified as held for sale) and the date that the asset is derecognised. The amortisation charge for each period is recognised in profit or loss unless the charge is a part of the cost of another asset. The amortisation period and method are reviewed at each financial year end. Any change in the period or method is accounted for as a change in accounting estimate prospectively. The Company derecognises an intangible asset on its disposal or when no future economic benefits are expected from its use or disposal and any gain or loss on derecognition is recognised in profit or loss as gain / loss on derecognition of asset.

2.1.14.a Transition to Ind AS

On transition to Ind AS, the Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as at the beginning of 1st April, 2020 (transition date) measured as per the previous GAAP and use that carrying value as the deemed cost of property, plant and equipment.

2.1.15 Income Taxes

Income tax expense represents the sum of tax currently payable and deferred tax. Tax is recognised in profit or loss except to the extent that it relates to items recognised directly in equity or in other comprehensive income.

2.1.15. a Current Tax

Current Tax includes provision for income tax computed at the tax rate applicable as per Income Tax Act, 1961. Tax on profit for the period is determined on the basis of estimated taxable income and tax credits computed in accordance with the provision of the relevant tax laws and based on expected outcome of assessments / appeals.



2.1.15.b Deferred Tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the balance sheet and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, unabsorbed losses and tax credits to the extent that it is probable that future taxable profits will be available against which those deductible temporary differences, unabsorbed losses and tax credits will be utilised. The carrying amount of deferred tax assets is reviewed at the end of financial year and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered. Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is expected to be settled or the asset realised, based on tax rates and tax laws that have been substantively enacted by the balance sheet date. Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Company intends to settle its current tax assets and liabilities on a net basis.

2.1.16 Assets Held for Sale

The Company classifies assets as held for sale if their carrying amounts will be recovered principally through a sale rather than through continuing use of the assets and actions required to complete such sale indicate that it is unlikely that significant changes to the plan to sell will be made or that the decision to sell will be withdrawn. Also, such assets are classified as held for sale only if the management expects to complete the sale within one year from the date of classification. Assets classified as held for sale are measured at the lower of their carrying amount and the fair value less cost to sell. Non-current assets are not depreciated or amortized.

2.1.17 Fair Value Measurement

The Company measures financial instruments at fair value in accordance with the accounting policies mentioned above. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for asset or liability, or
- In the absence of a principal market, in the most advantageous market for asset or liability.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy that categorizes into three levels, described as follows, the inputs to valuation techniques used to measure value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs).

Level 1 - quoted market prices in active markets for identical assets or liabilities

Level 2 - inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly

Level 3 - inputs that are unobservable for the asset or liability



For assets and liabilities that are recognized in the financial statements at fair value on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorization at the end of each reporting period and discloses the same.

2.1.19 Dividend

The Company recognises a liability for dividends to equity holders of the Company when the dividend is approved by the shareholders. A corresponding amount is recognised directly in equity.

2.1.20 Cash and cash equivalents

Cash comprises cash on hand and demand deposits with banks. Cash equivalents are short-term balances (with an original maturity of three months or less from the date of acquisition), which are subject to an insignificant risk of changes in value.

For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above, net of outstanding bank overdrafts as they are considered an integral part of the Company's cash management.

2.1.21 Statement of Cash flows

Cash flows are reported using the indirect method, whereby profit / (loss) before tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from operating, investing and financing activities of the Company are segregated based on the available information.

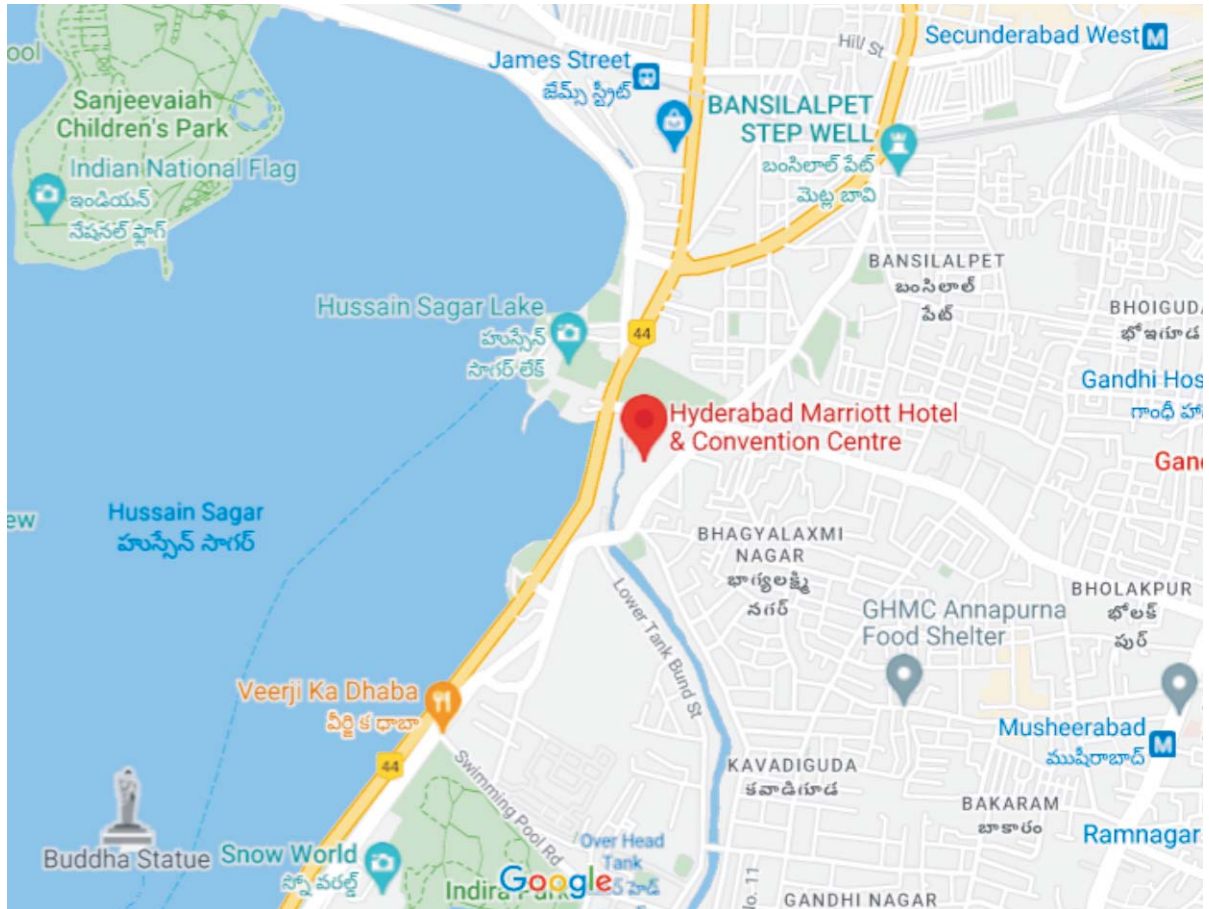
