O R D E R

1. Mr. Nand Kishore Kalal, Vice Chairman, Ghaziabad Development Authority, is present before this Court in person in compliance with our order dated 14.08.2026.

2. Learned counsel appearing for the respondent / contemnor, upon instructions, submits that steps have already been initiated for compliance of the order passed by this Court on 10.06.2026 in SLP (Civil) No. 21602/2026. It is submitted that the necessary corrections in the records have already been done by mutating the name of the SLP petitioner in the concerned records maintained by the Ghaziabad Development Authority (GDA).

3. In view of the above, and since the contempt has already been purged, there is no necessity to keep this contempt proceeding pending. The contempt

petition is, accordingly, disposed of.

4. Mr. Siddharth Dave, learned senior counsel appearing for Shipra Hotels Limited, submits that an application seeking impleadment / intervention has been filed.

5. We are of the considered view that the present proceedings are confined to the question of alleged contempt and compliance of our order dated 10.06.2026 in SLP (Civil) No. 21602/2026, therefore, a third party cannot be impleaded in such contempt proceedings. It will remain open for the implead applicant to maintain any other proceedings as is available in law.

6. It is informed that an application for modification / recall of the order passed in SLP (Civil) No. 21602/2026 has already been filed by Shipra Hotels Limited. The same shall be considered on its own merits in accordance with law.
