Subject: Application for Re-classification from Promoter Category to Public Category pursuant to Regulation 31A of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Members of the Board,

Raconteur Granite Limited ("RGL") hereby submits this application seeking reclassification of its status from the *Promoter Category* to the *Public Category* in Pipan Oils Limited (Formerly known as Omansh Enterprises Limited) ("the Company"), pursuant to Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time.

On behalf of RGL and the persons related to RGL (as defined under Regulation 2(1)(pp)(ii) to (iv) of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018), we confirm the following:

- RGL presently holds 5,00,000 equity shares in the Company, representing 2.85% of the total voting rights.
- Neither RGL nor any persons related to RGL exercise any control, directly or indirectly, over the affairs or management of the Company.

In view of the above, RGL respectfully requests the Board of Directors of the Company to consider and approve the request for reclassification and to initiate the necessary steps in accordance with the procedure laid down under Regulation 31A of the SEBI (LODR) Regulations, 2015.

Further, RGL affirms and undertakes that it and the persons related to it satisfy all the conditions prescribed under Regulation 31A(3)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, including but not limited to the following:

1. RGL and related persons collectively hold less than 10% of the total voting rights in the Company (current holding is 2.85%).
2. RGL and related persons do not exercise control over the Company, directly or indirectly.
3. RGL and related persons do not possess any special rights with respect to the Company, whether formal or informal, including through any shareholders' agreements.
4. RGL is not represented on the Board of Directors of the Company (including by way of nomination) and undertakes that it shall not be so represented for a period of three years from the date of shareholder approval of the reclassification.
5. RGL does not act as a Key Managerial Personnel (KMP) of the Company and undertakes not to act in such capacity for a period of three years from the date of shareholder approval of the reclassification.


6. Neither RGL nor any person related to it is a wilful defaulter as per the guidelines issued by the Reserve Bank of India.
7. Neither RGL nor any person related to it is a fugitive economic offender.
8. There is no pending regulatory action against RGL
9. RGL shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 at all times from the date of reclassification, failing which, RGL shall be reclassified as promoter/person belonging to promoter group of the Company.
10. RGL shall comply with the conditions mentioned in the sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for a period of not less than three years from the date of reclassification, failing which, RGL shall be reclassified as promoter/ person belonging to promoter group of the Company

We kindly request that this application be placed before the Board at the upcoming meeting for its consideration and further action as per the applicable provisions of the SEBI (LODR) Regulations, 2015.
