O R D E R

We are informed that the petitioners, Ascot Hotel & Resorts Ltd. and others, filed Review Petition No. 3/2021 before the Debts Recovery Appellate Tribunal¹, Delhi, in relation to the order dated 01.04.2016 passed by the said Tribunal in I.A. No. 26/2016 in Appeal No. 335/2015, arising out of O.A. No. 224/2013 (Delhi-II).
