1. Learned Advocate Mr. Darshankumar Kabra with learned advocate Ms. Paurami Sheth for the plaintiff has tendered purshish dated 17.09.2026 and has submitted that the plaintiff wishes to discontinue and unconditionally withdraw the captioned Suit, and accordingly seeks order of this Court permitting withdrawal of the Suit, return of the security deposited by the defendant towards the plaintiff's claim in the Suit and incidental directions. The said purshish is taken on record and forms part of this order.

2. Heard Learned advocates Mr. Darshankumar Kabra with Ms. Paurami Sheth for the plaintiff and learned advocate Mr Pratik Khubchandani for M/s Vyas Associates.

3. In view of the purshish filed by the plaintiff and submissions made, the captioned Suit stands disposed of as withdrawn unconditionally without an effective hearing.

4. The Registry is hereby directed to forthwith return and remit the security deposited by the defendant vessel / her Owner, through its P & I Club The United Kingdom Mutual Steam Ship Assurance Association Limited, in this Court, in the sum of USD 650,000/- with accrued interest, to the Defendant Vessel's P & I Club, i.e. The United Kingdom Mutual Steam Ship Assurance Association Limited. 6. Suit accordingly stands disposed of as unconditionally withdrawn.

7. All parties to act on an ordinary copy of this order.

In view of the order passed in the Admiralty Suit, the Civil Application for direction would not survive and the same stands disposed of.
