ORDER

1. Leave granted.
2. This civil appeal is disposed of in terms of the order dated 25th February, 2026 passed by a co-ordinate Bench of this Court in Civil Appeal No.3089 and Civil Appeal No.3090 of 2026.

4. Appellant is granted liberty to approach the Vice-Chancellor of the Maharashtra University of Health Sciences, Nashik¹ with website copies of this order and the order dated 25th February, 2026 in course of tomorrow.
5. If an approach is made, the Vice-Chancellor shall ensure that the marks statement of the M.B.B.S. examination and/or Pass Certificate, by whatever name called, is made over to the appellant on the same day, if possible, but in any case, not later than 11.00 hours of 17th August, 2026.

6. However, since the time is short, we grant the appellant time till Friday next, i.e., 21st August, 2026, to make payment of Rs.10,00,000/- (Rupees ten lakh) only in the account of the University through electronic mode or otherwise.

7. In the event the payment is not made by next Friday, i.e., 21st August, 2026, the Vice-Chancellor of the University is granted liberty to inform the National Board of Examination² about such non-deposit. In such an event, it shall be open to the Board to withdraw any admission secured by the appellant or benefit obtained in terms of this order.

8. Pending application(s), if any, shall also stand disposed of.
