Initiation of Process for Change of Flag/Re-Registration of Vessel.**

Pursuant to **Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**, we wish to inform you that the Company has **initiated the process for change of flag/re-registration** of its vessel **M.V. BHARADWAJ**, bearing **IMO No. 9290189**, which is presently registered under the **Indian Flag** with the **Registrar of Indian Ships, Chennai Port**.

The Company proposes to change the flag/registration of the vessel from the **Indian Flag** to the **Flag of St. Kitts & Nevis (SKN)**, subject to completion of all applicable statutory, regulatory and other requisite approvals, permissions, registrations and formalities from the concerned authorities.

The proposed change of flag / re-registration is being undertaken as part of the **Company's ongoing business and operational strategy** and is expected to provide **greater operational flexibility in the deployment and utilisation of the vessel**, facilitate **ease of doing business in international operations**, and support the Company's **international business activities, operational efficiency and future growth opportunities**.
