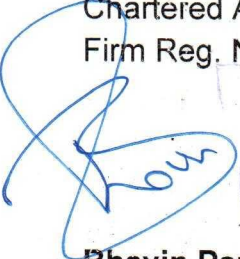

1. 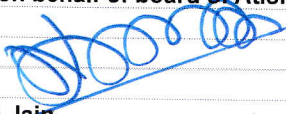

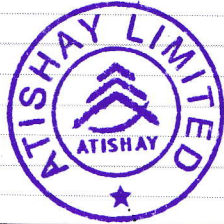


Notes to the unaudited standalone financial results for the quarter ended June 30, 2026:

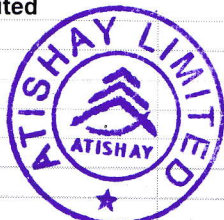
