UPON hearing the counsel the Court made the following
O R D E R

1. Despite our order dated 13.07.2026, learned counsel for the petitioners submitted that the interim order passed by this Court has not yet been complied with.
2. Let the Registrar (Judicial) of the Rajasthan High Court conduct a preliminary enquiry against Shri Sanjeev Mago, District and Sessions Judge, Dholpur and submit a report to this Court within two weeks.
3. The District and Sessions Judge, Dholpur shall cause

a spot inspection and obtain documents as to whether the machines under attachment are in use for production for the period after the interim order was passed by this Court.

4. The respondent shall submit the entire account of the production from the date this Court had passed the interim order.

5. The District Judge shall seek assistance of the concerned Superintendent of Police in preparing the report, as desired by this Court.

6. At this stage, Shri Maninder Singh, learned senior counsel appearing for respondent no.3 proposes that the parties may enter into a mediation. It will remain open for the parties to proceed for mediation and inform the outcome thereof, on the next date of hearing.

7. Post the matter on 19.08.2026.
