Sub: Intimation regarding a fire incident occurred at our Factory, M/s. Elin Electronics Limited, Ghaziabad.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that on Monday, 25th May 2026, at around 03:55 p.m. (IST), a fire incident occurred at the factory M/s. Elin Electronics Limited, situated at C-142, C-143, C-144, C-144/1, C-144/2 Buland Shahar Road Industrial Area, Ghaziabad (Uttar Pradesh) 201009.

Impact on Operations:

Fire was controlled within time and fortunately, there were no casualty and injury to life. However, the affected area will be temporarily shut and rest of plant is operating. We are currently assessing the full extent of the damage caused.

Insurance Coverage:

We would like to state that the Asset at the affected plant is adequately insured, and the firm has already intimated the insurance company for the incident and insurance survey is expected to be conducted in due course.
