1. Heard Mr. Ali Asghar Rahim, learned counsel appearing for the claimant-petitioner and Mr. Rajesh Kumar Gupta, learned counsel appearing for the respondent along with Mr. Gopal Juneja, Regional Manager, New India Assurance Company Limited.

2. During the hearing, the parties have arrived at a consensus and it is agreed that the New India

Assurance Company Limited will pay a consolidated amount of Rs.7,00,000/- (Rupees Seven Lakhs only) over and above the amount awarded by the High Court, in full and final settlement of all claims of the petitioner. The petitioner agrees that on receipt of the consolidated amount of Rs.7,00,000/- (Rupees Seven Lakhs) over and above the amount awarded by the High Court, the petitioner will have no further claim against the Insurance Company.

3. The petitioner shall furnish the account details to the Insurance Company. On due verification, the amount of Rs.7,00,000/- (Rupees Seven Lakh Only) shall be transferred to the petitioner within a period of six weeks from today.

4. The Special Leave Petition is disposed of in the above terms.
