**UPON hearing the counsel the Court made the following
O R D E R**

1. Heard-in-part.
2. We require an affidavit from the respondent no.2¹ with regard to the sale transaction at Annexure A-2 of the affidavit dated 25th October, 2025 as well as whether the respondent no.2 has been running a business venture in the name and style of Pruthi Global Traders, as discerned from Annexure A-3 thereto. In particular, the respondent no.2 shall state in the affidavit the source of funds with which the property forming part of the sale deed was purchased.
3. Let such affidavit be filed by 10 (ten) days from date. Rejoinder thereto, if any, may be filed within a week thereafter.
4. Re-list the civil appeal on 07th October, 2026.
5. Interim order, if any, shall continue till the next date of hearing.
