UPON hearing the counsel the Court made the following  
O R D E R

Leave granted.

Paragraph 25 is reproduced hereunder :

"25. In view of the aforesaid

discussion, and upon balancing the competing considerations arising in the present matter, including the prolonged service rendered by the concerned workmen on the one hand and the precarious financial condition of the Corporation on the other, we deem it appropriate to direct the State of Bihar to pay a lump sum amount of Rs. 7,50,000/- (Rupees Seven Lakh Fifty Thousand only) to each of the 330/338 members of the appellant-Union towards full and final settlement of their claims. The State of Bihar shall ensure that the aforesaid amount is disbursed to the concerned members of the appellant-Union within a period of three months from today."

The appeal is allowed in terms of the signed order which is placed on the file.

Pending application(s), if any, shall stand disposed of.

The State of Bihar shall file a compliance affidavit by 31<sup>st</sup> August, 2026. List on 1<sup>st</sup> September, 2026 for perusal of the said compliance affidavit.
