Subject: Resignation from the Office of Statutory Auditor

Dear Sir/Madam,

I hereby tender my resignation from the office of **Statutory Auditor of Pulsar International Limited**, with effect from **17 August 2026**, for the following professional and practical reasons:

1. Appointment pursuant to casual vacancy:

The audit assignment for the financial year **2025–26** was undertaken pursuant to the appointment made to fill the casual vacancy in the office of Statutory Auditor. In view of the circumstances and the time available for completing the audit, it has become difficult to continue with the assignment and complete the audit process within the required timelines.

2. Shortage of professional staff and timely availability of information:

Due to a shortage of professional staff and the consequent inability to deploy adequate resources for the assignment, I am unable to provide the required professional services within the desired timelines. Further, there have been practical difficulties in obtaining the requisite information, records, explanations and access to relevant data from the Company in a timely manner. These circumstances have resulted in delays in completing the audit procedures and reaching the necessary audit conclusions and finalising the audit report.

Considering the above circumstances, and in order to ensure that the Company is able to complete its statutory audit and comply with the applicable statutory and regulatory timelines without further delay, I consider it appropriate to resign from the office of Statutory Auditor with effect from **17 August 2026**.

I confirm that my resignation is **not on account of any dispute, disagreement or professional misconduct on the part of the Company or its management**, but is primarily due to the aforesaid professional resource constraints and practical difficulties in timely completion of the audit assignment.

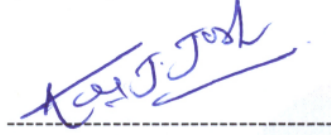

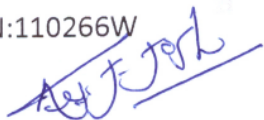
