During inspection the sample of 'Turmeric Powder' was collected and upon analysis, it was found that the same was not in confirmation of the relevant provision of the Laws.</p> <p>Subsequently, the Food Safety Officer filed a complaint before Additional District Magistrate, Rampur alleging violation of the provisions of the Food Safety and Standards Act, 2006. Pursuant thereto, a penalty of Rs. 80,000/- (Rupees Eighty Thousand Only) has been imposed on the Store Manager and Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand Only) has been imposed upon the Subsidiary. Hence, a total penalty of Rs. 2,00,000/- (Rupees Two Lakh Only) has been imposed.</p>

There is no material impact on operations or other activities of the Company due to the said order.
