Pursuant to Regulation 30 read with sub-para (20) of para (A) of part (A) of Schedule III of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, as amended, ('**SEBI LODR Regulations**') we, DOMS Industries Limited ('**the Company**'), wish to inform that the Company has received the Final Order dated May 05, 2026, issued by the Office of the Commissioner of Customs (Appeals), Mumbai-II under Section 128A of the Customs Act, 1962, in relation to the alleged misclassification of certain goods imported by the Company, which resulted in short payment of Goods and Services Tax ('**GST**').

The Company had earlier received an Order-in-Original dated November 30, 2023, from the Office of the Commissioner of Customs, NS-V, under the Customs Act, 1962, and being aggrieved by the same, had preferred an appeal. The Final Order now received upholds the said Order-in-Original, with a modification limited to the recalculation of the demand.

The Final Order was received by the Company on May 19, 2026.
