The project will also connect **2,500 public institutions**, including **2,000 schools** and **500 government offices**. The projects also aims 50 lakhs successful digital authentications for service delivery and reducing retail data prices as percentage of GNI per capita – from **9.4% to 4%**.

As part of the engagement, CSM Tech Limited will undertake the complete lifecycle of the project, including business requirements assessment, platform architecture and development, system integration, cybersecurity hardening, penetration testing, pilot implementation, production rollout, user training, knowledge transfer and post-deployment warranty support.
