UPON hearing the counsel the Court made the following
O R D E R

1. Permission to file Special Leave Petition is granted.
2. Heard Mr. Rajiv Dutta, learned Senior Counsel for the petitioners. Learned Senior Counsel's grievance is that, while it was at their behest that the administrator in resepct of the Sarvodaya Cooperative Housing Society Ltd. (for short, 'Society') came to be appointed, the respondents have moved the writ petition before the High Court, without impleading them as a party in the said writ petition and the order

appointing the administrator came to be quashed.

3. At this stage, learned Senior Counsel for the petitioners submits that he seeks leave to withdraw the present Special Leave Petition with a liberty to go back to the High Court in accordance with the law laid down by this Court and seek appropriate reliefs.

4. Liberty is granted to withdraw the present Special Leave Petition with the aforesaid liberty.

5. We also record that in the event of any adverse order being passed on the application/petition which the petitioners prefer to move, the petitioners shall have the liberty to, not only challenge the adverse order, but also the present impugned order.

6. With the above observations, the Special Leave Petition is disposed of as withdrawn.

7. Pending application(s), if any, shall also stand disposed of.
