**I HEREBY SUBMIT MY REPORT ON THE VOTING ON THE RESOLUTION PROPOSED IN THE POSTAL BALLOT NOTICE, AS UNDER:**

1. In terms of Section 108 and Section 110 of the Companies Act, 2013 read with the Rules and the Listing Regulations, 2015, the Company had made arrangement with National Securities Depository Limited for providing facility of voting through Remote E-voting to its members.
2. As informed the Company sent Postal Ballot Notice, along with Explanatory Statement pursuant to Section 102 of the Act on June 02, 2026 by the electronic mode (e-mail) to those members whose email addresses were (registered with the Company / Depository Participants, pursuant to the aforementioned MCA Circulars/Notifications. A copy of said Postal Ballot Notice was published on the website of the Company and NSDL.
3. Pursuant to MCA Circulars, physical ballots were not dispatched. Accordingly, the communication of the assent or dissent of the members had taken place through the Remote E-voting only.
4. As per the sub-rule (3) of Rule 22 of the Rules and MCA Circulars, the Company published an advertisement on Wednesday, June 03, 2026 about dispatch of Postal Ballot Notice in 'Financial Express' (English) & Jansatta (Hindi) Newspapers.
5. The members of the Company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained for it by the Depositories (in case of shares held in dematerialized form) as on the cut-off date i.e. Friday, May 29, 2026 were entitled to avail Remote E-voting facility, in respect of resolution(s) as set out in the Postal Ballot Notice.
6. In terms of Postal Ballot notice the e-voting commenced on Friday, June 5, 2026 at (9:00 A.M. IST) and ended on Saturday, July 04, 2026 (5:00 P.M. IST).
7. All votes cast through Remote E-voting during the above-mentioned period, were considered for scrutiny and at the end of Remote E-voting period, the Remote E-voting facility was blocked by NSDL forthwith.
8. After the conclusion of Remote E-voting, the votes cast by the members through Remote E-voting facility were unblocked at around 06-45 PM on Saturday July 04, 2026 in the presence of two witnesses who are not in employment of the Company.
9. The Votes cast by the members through Remote E-voting, were reconciled with the Register of Members/ list of beneficial owners/other relevant records of the Company on Saturday, July 04, 2026.
10. The votes cast through Remote E-voting were scrutinized by me for verification of votes cast in favour and against the resolution.
11. The particulars of voting and other requisite details have been entered in a separate Register maintained for the purpose.
12. The summary of the votes cast is as given below:  
Total 128 shareholders (28546809 equity shares) voted, out of which 99 shareholders (28178501) equity shares) voted in favour of the below mentioned resolution & 29 shareholders (368308 equity shares) voted against the resolution.
