**UPON hearing the counsel the Court made the following
O R D E R**

- 1.** The parties are granted four weeks' time to complete the pleadings.
- 2.** Mr. Mukunda Rao Angara, learned AOR is hereby nominated as the Nodal Counsel who shall ensure that the pleadings are in one compilation known as 'convenience compilation' and the learned counsels appearing for the respective parties shall furnish the pleadings, the documents, if any, relied upon to be part of 'convenience compilation'.
- 3.** It is made clear that no document which is not part of 'convenience compilation' will be looked into at the time of hearing of the matter. Hence, we request the Nodal Counsel to ensure that 'convenience compilation' would contain all the pleadings and documents relied upon by the parties. This exercise shall be undertaken by the learned Nodal Counsel within four weeks from the date of the pleadings are filed. The soft copies of the same shall also be made available to the Registry and to the respective learned counsels. Since Union of India is also a party, the copy of the 'convenience compilation' shall also be filed with the Central Agency of Union of India.
