	Brief details of dispute / litigation	Optimus Drug terminated supply agreement contrary to the agreed terms. The Company being aggrieved in this respect, has initiated arbitration proceeding against the Optimus Drugs, claiming <i>inter alia</i> ; (a) Rs. 75,00,00,000 towards Break Fees because Optimus Drugs breached the mandatory "Take-or-Pay" minimum purchase obligations outlined in the agreement; (b) Rs. 23,80,849/- towards the interest on Delayed Payments, and further interest till actual payment; (c) Rs. 15,00,00,000/- towards the damages and financial losses; and (d) costs, other relief as the Hon'ble Tribunal may deem fit.
2	Expected financial implications, if any, due to compensation, penalty, etc.	Since the Company has initiated arbitration proceeding claiming recovery and damage, we do not expect any financial implication due to penalty etc.
