- Resolution No. 3 : Re-appointment of Mr. Vikas Oberoi as a Director, who retires by rotation
- Resolution No. 4 : Ratification of remuneration payable to M/s. Kishore Bhatia and Associates, Cost Auditors of the Company for the financial year ending March 31, 2027
- Resolution No. 5 : Approval of issue of equity shares and/or any other securities convertible into equity by way of qualified institutions placement/s
