O R D E R

We have heard the learned Senior counsel appearing

for the petitioner and learned Senior counsel appearing for the respondent(s).

Though the learned Senior counsel appearing for the petitioner is correct in his submission made with respect to the application of Clause 25 of the General Standing Order 170/2020 dated 14.12.2020, the fact remains that the official respondents did not intend to renew the license awarded to the petitioner and, in fact, in the subsequent tender, the petitioner had participated without prejudice to any of his contentions.

In such view of the matter, no ground is made out for interference.

However, the petitioner is granted a period of six weeks to hand over the vacant physical possession of the licensed subject premises, subject to filing an unconditional undertaking on oath before this Court within a period of two weeks from the date of receipt of a copy of this order for vacating the subject premises in the aforesaid terms

The Special Leave Petition stands dismissed with the aforesaid liberty.
