At the very outset, learned counsel appearing for the parties jointly submit that the issue involved in this petition is no longer res integra and this petition is squarely covered by the judgment passed by Co-ordinate Bench in WPT No. 248 of 2022 parties being *BEC Fertilizers Versus Municipal Corporation, Bilaspur and Others* which was decided on 10.09.2024.
2. In the light of the submission made herein-above, this Court is of the opinion that this petition is squarely covered by the judgment rendered by Co-ordinate Bench in **WPT No. 248 of 2022** decided on 10.09.2024 in case of ***BEC Fertilizers and Others Versus State of Chhattisgarh and Others***.
3. Accordingly, this petition is **disposed** in terms of the order passed by Co-ordinate Bench in the case of **BEC Fertilizers** (supra). The interim order dated 27.01.2023 is extended till the representations made by the petitioner is decided by the State. It is made clear that the petitioner shall submit representation before the State Government within stipulated time period granted in the case of

BEC Fertilizers (supra) failing which the interim order after cut-off date will lose its significance automatically.
