08.09.2026: **IA No. 6275 of 2026**- We have heard Ld. Counsel for the applicant as well as Shri Kunal Kanungo Ld. Counsel appearing for opposite party no. 1 and 2 as well as Shri Anuj Solanki for opposite party no. 3 and perused the record.

The instant application has been filed by the applicant with the request to implead it in the instant appeal on the ground that the applicant is an operational creditor and is the largest creditor so far as the amount is concerned as well as he was also asked to join the proceedings by the Ld. Adjudicating Authority and therefore he is having interest in the outcome of the instant appeal.

Ld. Counsel for the opposite parties fairly submits that they are not having any objection if the applicant is impleaded in these proceedings.

Keeping in view the submissions made by Ld. Counsel for the applicant in terms that it is the largest creditor, which has not been denied by the opposite parties and also the fact that it was asked to join the proceedings before the Ld. Adjudicating Authority, we find substance in the application

moved by the applicant. Thus for the reasons stated aforesaid the IA No. 6275 of 2026 filed by the applicant is allowed and the Applicant-Chemical Corporation Pvt. Ltd. is impleaded as Respondent No. 3 in the appeal.

The appellant is directed to immediately file the amended memo of parties.

IA No. 6266 of 2026- The instant application has been moved by the Chemical Corporation Pvt. Ltd. (the application for impleadment of which has been allowed by us) with the following prayer:

“a.Stay the proceedings of I.A.(IBC) (PLAN)/68/2026 in CP (IB)/686(MB)2025 pending before the Ld. Adjudicating Authority.

b.Any other relief as this court may deem fit and proper”.

We in the interest of justice provide an opportunity to the appellant of appeal as well as to the Respondents of the original appeal to bring on record any response to the stay application filed by the applicant/newly impleaded Respondent No. 3.
