Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that due to unprecedented heavy rainfall in Silvassa, the Company's manufacturing plant located at Silvassa (Dadra & Nagar Haveli), U.T. – 396230, has been affected by flood-like conditions.

During the last 48 hours, Silvassa received extremely heavy rainfall, causing severe waterlogging and flooding across several parts of the area of Silvassa, (Dadra & Nagar Haveli).

We are currently assessing the impact of this natural calamity, if any, on the Company's assets, operations, and production. The extent of the impact is being evaluated, and appropriate measures are being taken to restore normal operations at the earliest.

The Company will keep the stock exchanges informed of any material developments, if required, in accordance with the applicable provisions of the SEBI (LODR) Regulations, 2015.
