 O R D E R

2. On the other hand, the learned counsel appearing for the Respondent No.1 submitted that he would like to sit with the appellant - IFCL Limited and try to resolve the issues amicably.
3. We take notice of the fact that the impugned Judgment and Order passed by the High Court dated 21-8-2019 has been stayed from its operation. It has been now almost 7 years that the interim relief is in operation.

4. We believe that by putting forward some proposals to resolve the disputes, if the matter can be put to an end, then there should not be any problem.

5. Let the parties try to talk with each other and try to resolve the disputes amicably, failing which we shall proceed to hear the matters on its own merit.

6. Put it after six weeks.
