Subject: Disclosure with regard to Order received by Abacus Real Estate Pvt Ltd, a wholly owned subsidiary of the Company, from Commissioner of Income Tax (Appeal), Mumbai

Reference: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Dear Sir/Madam,

Pursuant to SEBI Listing Regulations, we inform you that Abacus Real Estate Pvt Ltd, a wholly owned subsidiary of the Company (“**Abacus**”) has received an Order (“**Order**”) passed by the Commissioner of Income Tax (Appeal), Mumbai (“**CIT(A)**”).

Abacus had filed an appeal before the CIT(A) against the assessment order passed by the Income Tax Officer for the Assessment Year 2013-14, making an addition to the income resulting into tax demand including interest of Rs. 15.44 crore. Reference of the appeal filed by Abacus is made in the prospectus dated June 26, 2025 filed by the Company.

As a result of the aforesaid appeal proceedings, we wish to inform that CIT (A) has dismissed the appeal filed by Abacus and has sustained the additions to the income made by the Income Tax officer. The net tax demand including interest amounts to Rs. 9.20 crore (total tax demand Rs. 15.44 crore less amount paid Rs. 6.24 crore).

The said Order does not have any material financial impact on the operations of the Company. Abacus shall contest the said Order/ file an appeal as per the applicable provisions of Income Tax Act, and is hopeful of a favorable outcome.

The Company has received information about the receipt of Order by Abacus at 3:45 p.m. on July 3, 2026.
